FAMILY PROCEDURE RULE COMMITTEE ANNUAL REPORT 2004-05

Terms of Reference

1. The Family Procedure Rule Committee is an Advisory Non-Departmental Public Body sponsored by the Department for Constitutional Affairs. Its function is to make rules of court governing the practice and procedure in family proceedings in the High Court, county courts and magistrates' courts. Its power to make rules is to be exercised with a view to securing that the family justice system is accessible, fair and efficient and the rules are both simple and simply expressed. Before making rules the Committee must consult such persons as it considers appropriate and meet (unless it is inexpedient to do so).

Background

2. The Family Procedure Rule Committee was established in 2004 in accordance with the provisions of the Courts Act 2003. To date, the power of the Committee to make rules has been brought into force only in regard to matters relating to adoption.

Remuneration

4. The Chair and members are not remunerated for their service on the Committee.

Meetings

5. The Committee met on 11 November, 6 December (2004), 10 January, 14

February, 7 March, 11 April, 9 May, 13 June, 11 July, 5 September, 7 October (2005).

New Rules/Statutory Instruments

6. The Committee has made the Family Procedure (Adoption) Rules 2005 – S.I. 2005 No. 2795 (L.22). These rules support the major reforms in adoption law enacted in the Adoption and Children Act 2002 and shall come into force on the 30 December 2005. They are the first rules made by the Committee and the first family rules to apply to all levels of court below the Court of Appeal.

Pending the bringing into force of its full rule-making powers under the Courts Act, rules in relation to family proceedings in the High Court and county courts continue to be made under the provisions of s.40 Matrimonial and Family Proceedings Act 1984. All those currently appointed to make rules under s.40 are members of the Family Procedure Rule Committee.

During the year the Committee has considered, and those members appointed under s.40 have made, together with the Lord Chancellor, amendments to the Family Proceedings Rules 1991 to give effect to:

- Council Regulation (EC) No. 2201 of 2003 of 27 November 2003 concerning jurisdiction and the recognition and enforcement of judgments in matrimonial matters and the matters of parental responsibility
- The Gender Recognition Act 2004
- The Children Act 2004 (s.37 Welsh family proceedings officers)
- The Children Act 2004 (s.62 Publication of material relating to legal proceedings)
- The Civil Partnership Act 2004
- The Adoption and Children Act 2002
 Additionally, amendments have been made to ancillary relief Form E and to provisions relating to pension sharing.
