Re: S31 Special Educational Needs and Disability (SEND) Implementation Grant (New Burdens) Determination Letter 2014-2015 [DfE CSDSD2/2014] [31/2376]

This Determination is made between:

(1) The Secretary of State for Education and

(2) The local authorities listed at Annex A

Purpose of the Grant

The purpose of this grant is to provide support to local authorities in England towards additional expenditure lawfully incurred or to be incurred by them in implementing the SEND reforms, including in transferring children and young people from statements and young people in further education or training who had Learning Difficulty Assessments to Education, Health and Care plans. The funding is **£45.2million** for 2014-15 and an indicative amount of **£31.7 million** for 2015-16. This additional funding to support the implementation of the reforms is in addition to the £70 million SEN Reform Grant already provided to local authorities in 2014-15.

Local authorities can spend this grant to help with the additional costs associated with the implementation of the SEND reforms. They may, however, choose how to spend the money in order to best meet local need.

The Children and Families Act introduces new duties on local authorities in order to improve outcomes for children and young people with SEN or who are disabled, increase choice and control for parents, and promote a less adversarial system. Local authorities are undertaking a range of activities to prepare for these changes, which will be implemented from September 2014.

SEND IMPLEMENTATION [No CSDSD2/2014] GRANT DETERMINATION [2014/15]: [No. 31/2376]

The Secretary of State for Education ("the Secretary of State"), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1) This determination may be cited as the SEND Implementation [No. CSDSD2/2014] Grant Determination [2014/15] [No.31/2376]

Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them.

Determination

3) The Secretary of State determines the authorities to which grant is to be paid and the amount of grant to be paid; these are set out in Annex A.

Treasury consent

4) Before making this determination in relation to local authorities in England, the Secretary of State obtained the consent of the Treasury.

Payment arrangements

5) Grant will be paid in four instalments of as near equal value as possible on, or by, two payments to be paid together at the end of August 2014; end of November 2014 and at the end of February 2015.
