Thank you for your email of 26 April 2016 regarding rescues carried out by D Flt, 202 Sqn.

You asked:

Could you please provide the number of rescues carried out by D Flt, 202 Sqn based at RAF Lossiemouth from 1972 until it's disbandment. In particular could you provide details of the first and last rescue carried out.

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA). After a search of our records I can confirm that some information is held within the scope of your request.

The MOD only holds records from January 1983 and this is set out in the table below:

	Recorded between 1 Jan 1983 and 31 Mar 2015
First recorded rescue	2 Jan 1983 - Medrescue of 1 person from around Ben Macdui.
Last recorded rescue	31 March 2015 - Requested by Police Scotland (Fort William). The callout was to assist Lochaber Mountain Rescue Team with a search for a missing person. The search centred around the southern face of Ben Nevis; nothing was found.
Callouts	6741
Persons assisted	5905

Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
