- 5. From the **Column** drop down menu select **Category of pensions**
- 6. From the **Subset** drop down menu select the required option
- 7. From the Date drop down menu select required date
- 8. Click Get Table

- 1. Caseload figures are rounded to the nearest ten and some additional disclosure control has also been applied so totals may not sum due to rounding
- 2. The age at which women reach State Pension age is gradually increasing from 60 to 65 between April 2010 and April 2016 to November 2018. Under current legislation, State Pension age for men and women is planned to increase to: 66 between November 2018 and October 2020; 67 between 2034 and 2036; 68 between 2044 and 2046. This will introduce a small increase to the number of working age benefit recipients and a small reduction to the number of pension age recipients. Figures from May 2010 onwards reflect this change. - 3. Off flows include the total number of spells on this benefit that ended within the quarter. It does not include flows where people move out of one area and into another while remaining on the benefit.
