The primary purpose of this prior information notice (PIN) is to inform the markets of prospective opportunities in connection with the GB Smart Metering Implementation Programme (SMIP) and to seek feedback on our proposed approach.

The UK Government is committed to every home in Great Britain having smart energy meters, empowering people to manage their energy consumption and reduce their carbon emissions. Businesses and public sector users will also have smart or advanced energy metering suited to their needs. The rollout of smart meters will play an important role in Great Britain's transition to a low-carbon economy, and help us meet some of the long-term challenges we face in ensuring an affordable, secure and sustainable energy supply.

Communication of data to and from smart meters in the domestic sector will be managed centrally by a new, GB-wide function covering both the electricity and gas sectors. We refer to this new function as the central data and communications company (DCC).

The new central data and communications function will provide a two-way communications channel between smart meters and a central communications hub to which smart meter data users (suppliers, network companies and other authorised third parties) will have access for specified purposes.

In order for DCC to provide services to its users it will be required to contract for a number of IT (data) and communication services.

In advance of the appointment of the DCC, it is intended that DECC would initiate the process for procurement of the data and communication services that will be contracted to DCC.

We are interested to hear from parties who wish to be considered for the data and communications service provision contracts or that have an interest in the SMIP so that we may include those parties in the circulation of information about the SMIP and seek input in a number of areas in order to inform the process for procurement of the services.

The process for seeking input will comprise of the issue of a Project Information Memorandum (PIM) setting out our proposed approach for the procurement of the data and communications services, an 'Industry Day' and completion of a data and communication services questionnaire by interested market participants. The Industry Day, where DECC will provide briefing on the SMIP, will be held in London in June.

Interested parties should in the first instance respond to this PIN and express their wish to receive further information and to participate in the data and communication services questionnaire. The form of response should be limited to the provision of a single point of contact (name, job title, email address and phone number). Responses should be received by DECC by 1.6.2011.
