Your email dated 26th May 2016 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

I would like to request a list of meetings that Susanna Mason attended during 2015.

I would like the list to cover all meetings that involved people who are not part of the Ministry of Defence and for the list to include: the date, length and location of each meeting; a list of those present (with names and positions for politicians and senior officials, and positions for those to whom Section 40 exemptions are applied); and the purpose of the meeting. I would like this to include meetings in both the UK and overseas.

Please provide the information in a table that shows where any information has been withheld and which is in a machine-readable form such as a spreadsheet. Please also include a list of any acronyms and abbreviations used.

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Attached is a table of meetings identified from a search of records held in the office of Director General Commercial, as being attended by, or hosted by, Susanna Mason during 2015 which involved people who are not part of the MOD. Positions are those which were held at the time of the meeting; some personnel may have changed position since then. Where a position is not known, it is not included.

In my letter dated 24th June 2016, I advised that some information was considered to fall within the scope of qualified exemption Section 43(2) (Commercial interests) of the FOIA, and that a public interest test would need to be undertaken to determine, in all cirmcustances of the case, whether information should be released in full, in part or withheld. I can advise that, as a result of further discussion and consideration of arguments, it was determined that there were no grounds to withhold information under Section 43(2) of the FOIA and no formal public interest test was required. Section 40(2), however, has been applied to some of the names in order to protect personal information of a third party as governed by the Data Protection Act 1998. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

Under Section 16 of the Act (advice and assistance), you may wish to note that a complete list of all meetings attended by Susanna Mason during 2015 is no longer held.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail <u>CIO-FOI-IR@mod.uk</u>). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
