ALB This document contains data from the Adoption Leadership Board (ALB) quarterly survey providing information on adopters in 2014-15 (April 2014 to March 2015).

Response In quarter 4 2014-15 the response rate for the adopter level section of the rate return was 95%. Therefore national and regional figures on adopters include estimates made for non-responses. Estimates are made by scaling to the regional level based on the number of adoptions in each LA during 2013-14 (from the SSDA903 data).
