

# Mexborough Advisory Forum – Terms of Reference

### Introduction

The Mexborough Advisory Forum was established to promote engagement between HS2 Ltd, DfT and local stakeholders in Mexborough to deliver the Government's commitment to help ensure that owner occupiers on the Shimmer Estate can secure a local comparable home, and enable strategic issues relating to property compensation within the Mexborough to be brought to the Forum's attention.

While it is anticipated the Mexborough Advisory Forum will convene on a short-term basis in order to deliver the Government's commitment, HS2 Ltd remain committed to ongoing, effective engagement with residents affected in this area.

## Purpose of the Mexborough Advisory Forum

- To promote understanding and awareness of the statutory blight and other compensation schemes available to those affected by HS2 in Mexborough, including the £30k cash offer schemes applicable within the Shimmer Estate
- To provide scrutiny and challenge of options (which will be consistent with existing housing support schemes) for Shimmer owner-occupiers who wish to relocate to a local comparable property, or remain on the Shimmer estate.
- To facilitate communication and engagement between DfT, HS2 Ltd, Mexborough residents, and local stakeholders.
- To ensure information and advice is communicated effectively to local stakeholders.
- To build relationships and trust between Mexborough and Shimmer estate residents, DfT and HS2 Ltd and other stakeholders.

The Mexborough Advisory Forum will not be responsible for dealing with individual blight claims, the general process of statutory blight, or HS2 issues beyond the commitment to ensure Shimmer residents can secure a comparable local property, and the discussion of strategic issues affecting land and property compensation affecting residents of the Mexborough area arising from HS2 proposals.
