* Due to further planned changes to the methodology for the dementia diagnoses rates by NHS England, indicator 4.16 has been updated at England level only. The definition has not been revised this time and local authority data have not been added, as had been previously announced.

The inclusion of inequalities data for indicators 2.23i, 2.23ii, 2.23iii and 2.23iv (Self reported wellbeing indicators) has been postponed due to issues discovered with the calculation of the indicator. It is hoped they will be included in the August update.

The indicator 3.02i (Chlamydia detection rate - old National Chlamydia Screening Programme data) has been removed. It was originally kept to provide a baseline for the newer Chlamydia Testing Activity Dataset (CTAD) figures and to provide continuity during the change of datasets. However, the dramatic improvement in quality of the CTAD data means this indicator is no longer required. The indicator 3.02ii - Chlamydia detection rate (15-24 year olds) – CTAD has subsequently been relabelled as indicator 3.02.
