THE COUNTY COUNCIL OF DURHAM (UNREGISTERED FOOTPATHS AT WILLOWTREE AVENUE, BELMONT PARISH) PUBLIC PATH STOPPING UP ORDER 2015

This Order is made by The County Council of Durham ("the Authority") under Section 257 of the Town and Country Planning Act 1990 ("the Act"), because it is satisfied that it is necessary to stop up the public footpaths to which this Order relates in order to enable development to be carried out in accordance with planning permission sought under Part III of the Town and Country Planning Act 1990 namely the construction of a residential development.

BY THIS ORDER:

- 1. The public footpaths over the land shown by a bold line on the attached map and described in Part 1 to the Schedule of this Order ("the Schedule") shall be stopped up.
- 2. The stopping up of the footpaths shall have effect on the confirmation of this order.
- 3. Where immediately before the date on which the footpaths are diverted if there are any apparatus under, in, on, over, along, across it belonging to statutory undertakers for the purpose of carrying on their undertaking, then, the undertakers shall continue to have the same rights in respect of the apparatus as they had then.


