THE NOTTINGHAMSHIRE COUNTY COUNCIL
(ARNOLD FOOTPATH NO. 56) MODIFICATION ORDER 2013

This Order is made by the Nottinghamshire County Council under Section 53(2)(b) of the Wildlife & Countryside Act 1981 ("the Act") because it appears to that Authority that the Nottinghamshire (Area 3) Definitive Map and Statement modification in consequence of the occurrence of an event specified in Section 53(3)(b) of the Act, namely the expiration of a period such that the enjoyment by the public of the way during the period raises the presumption that the way has been dedicated as a footpath over the land at Arnold.

The Authority have consulted with every Local Authority whose area includes land to which the Order relates.

The Nottinghamshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 1st August 2013.
2. The Nottinghamshire (Area 3) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the Map attached to this Order.
3. This Order shall take effect on the date it is confirmed and may be cited as "The Nottinghamshire County Council (Arnold Footpath No. 56) Modification Order 2013".



Commencing from a point, SK57704361, at the junction of Mansfield Road and proceeding in a generally easterly direction for a distance of approximately 55 metres on a tarmac surface and continuing in a generally easterly direction for a distance of approximately 65 metres on a earth surface and continuing in a generally easterly direction for a distance of approximately 75 metres on a tarmac surface to a point SK57884354 at the junction of Woodthorpe Drive and having a width of 3 metres throughout its entire length.
