Thank you for your email of 26 Nov requesting the following information:

Details of compensation claims that have been made against the MOD for damage caused by low-flying RAF jets in the years 2013, 2014 and 2015 (to date).

For each claim, please provide:

- 1) The total cost claimed
- 2) What aircraft was involved
- 3) Where the damage happened
- 4) A short description of the damage caused (e.g "smashed car window" or "injured horse")

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA). A search for the information has now been completed within the Ministry of Defence, and I can confirm that all the information in scope of your request is held.

The information you have requested can be found attached and is as at the date of this letter. Please note that the totals of compensation paid are inclusive of claimant's legal costs and other professional fees such as medical reports and valuations. Compensation payments made in calendar year may include settlement of claims submitted in earlier years.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act.

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed. Further details of the role and powers of the Information Commissioner can be found on the Commissioner's website, https://ico.org.uk/.
