Thank you for your email of 10 July in which you requested the following information:

- '1) The number of applications to join the British Army received during the years 2015, 2016 and up to June 2017, broken down by applications received in England, Scotland, Wales and Northern Ireland.
- 2) The number of applications during the period detailed above which were rejected, broken down by reason for rejection.
- 3) The number of applications rejected on the basis that the applicant had previously used or been prescribed antidepressant medicine(s).'

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held. Information requested in parts one and two of your information in scope of your request is held and is detailed in the tables below. Information requested in part three of your response is not held.
