DEFINITIVE MAP MODIFICATION ORDER 2014

This Order is made by Lincolnshire County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Definitive Map and Statement for Lindsey County Council (Rural District of Spilsby) require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available to it) shows that rights of which are not shown on the map and statement subsist or are reasonably alleged to subsist over land in the area to which the map relates, being rights of way such that the land over which the rights subsist are public paths.

The Authority has consulted with every local authority whose area includes the land to which the Order relates

1. For the purposes of this Order the relevant date is 27 October 2014
2. The Definitive Map and Statement for Lindsey County Council (Rural District of Spilsby) shall be modified as described in Part I and Part II of the Schedule and shown on the drawing attached to the Order
3. This Order shall take effect on the date it is confirmed and may be cited as the Wildlife and Countryside Act 1981, Lincolnshire County Council (New Leake Public Footpath Nos. 1107 & 1113) Definitive Map Modification Order 2014

Part 1

Modification of Definitive Map

**Description of Public paths to be added
in the parish of New Leake**

Footpath No. 1107

The path commences at Spilsby Road at Ordnance Survey Grid Reference TF 4018 5693 and runs in a westerly direction for approximately 225 metres to TF 3996 5694. It then runs northwards for approximately 358 metres along the field edge to TF 4002 5729. The path then runs in an eastward direction

along the northern boundary of the sewage works and then follows the concrete track eastwards for approximately 245 metres to meet Spilsby Road at TF 4026 5726.

The path runs for approximately 828 metres between points A-B-C-D and the width of the path is 2.5 metres. The path is shown on the attached plan 2014/005/DMMO/353/A4

Footpath No. 1113

The path runs from Footpath 1107 at TF 4002 5729 in a northerly direction along the field edge to TF 4006 5752 where it meets a drain.

The path runs for approximately 229 metres between the points C-E and the width of the path is 2.5 metres. The path is shown on the attached plan 2014/005/DMMO/353/A4.

Modification of Definitive Statement

Variation of Particulars of Path or Way **Description of Public paths to be added** **in the parish of New Leake**

Footpath No. 1107

The path commences at Spilsby Road at Ordnance Survey Grid Reference TF 4018 5693 and runs in a westerly direction for approximately 225 metres to TF 3996 5694. It then runs northwards for approximately 358 metres along the field edge to TF 4002 5729. The path then runs in an eastward direction along the northern boundary of the sewage works and then follows the concrete track eastwards for approximately 245 metres to meet Spilsby Road at TF 4026 5726.

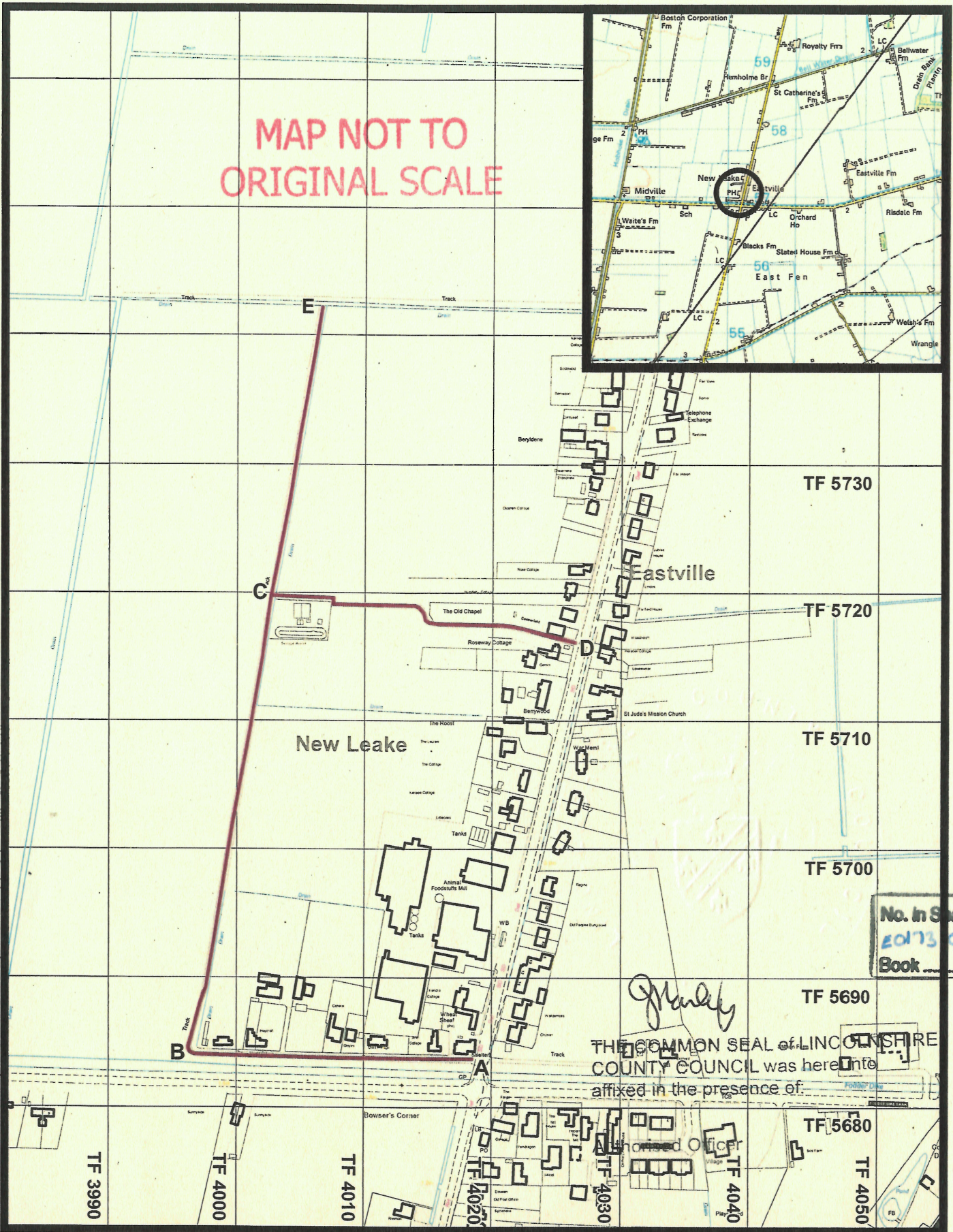
The path runs for approximately 828 metres and the width of the path is 2.5 metres.
