INTRODUCTION

- I am directed by the Secretary of State to draw your attention to the publication of new Approved Documents L1A and L2A, amendments to Approved Documents L1B and L2B and a new Domestic Building Services Compliance Guide and a new Non-Domestic Building Services Compliance Guide.
- 2. The Secretary of State, in exercise of his powers under section 6(1) of the Building Act 1984, has approved new Approved Documents L1A (2013) and L2A (2013). In exercise of his powers under section 6(4) of the Building Act 1984, the Secretary of State has approved revisions to Approved Documents L1B (2010) and L2B (2010). Formal notice of approval, as required by section 6(3) of the Building Act 1984, is given at Annex A to this Circular.
- 3. The approvals take effect as of 6 April 2014 subject to the transitional provisions detailed below and in the notice of approval.
- 4. The Secretary of State, in exercise of his powers under section 6(5) of the Building Act 1984, has withdrawn his approval in respect of Approved Documents L1A (2010) as amended and L2A (2010) as amended with the transitional arrangements set out below and in the notice of withdrawal of approval at Annex B.
- 5. The withdrawals of approval take effect as of 6 April 2014 subject to the transitional provisions set out below and in the notice of withdrawal of approval.
- 6. This Circular does not give technical guidance on compliance with the Building Regulations. Such guidance is given in the Approved Documents themselves.

APPROVED DOCUMENTS L1A (2013) AND L2A (2013)

7. These new approved documents provide consolidated guidance on the energy efficiency requirements of the Building Regulations 2010, including guidance on amendments to the requirements in the Regulations made since 2010.

AMENDMENTS TO APPROVED DOCUMENTS L1B (2010) AND L2B (2010)

8. The amendments to these approved documents are in addition to the earlier amendments made to them.

BUILDING SERVICES COMPLIANCE GUIDES (2013)

9. The guidance in these guides supplements the guidance in the new Approved Documents L1A (2013) and L2A (2013) and the amended Approved Documents L1B (2010) and L2B (2010).

TRANSITIONAL PROVISIONS

10. The transitional provisions for the Approved Documents and Compliance Guides follow those in the latest amendment to the energy efficiency provisions of the Building Regulations 2010 made by the Building Regulations &c. (Amendment) (No.2) Regulations 2013 (S.I. 2013/1959).

- 11. The guidance in the new approved documents, the amendments to existing approved documents and the new compliance guides which are the subject of this Circular comes into effect on 6 April 2014 except in the following circumstances where the guidance in the previous approved documents and compliance guides may continue to be used:
 - i. where work has commenced before 6 April 2014; or
 - ii. where a building notice, initial notice, combined initial notice and plans certificate or amendment notice have been given, or a full plans application has been deposited, before 6 April 2014, provided in each case that the building work has commenced before 6 April 2015.
