#### TREATIES FOR WHICH THE UK IS DEPOSITARY

Treaty on the Non-Proliferation of Nuclear Weapons [London Version] (London, 1 July 1968)

**Action: Palestine: Accession** 

This instrument was received and deposited in the archives of the Government of the United Kingdom of Great Britain and Northern Ireland on 12 February 2015. In accordance with Article 9(4), the Treaty entered into force for the Palestine on the same date.

Convention for the Suppression of Unlawful Seizure of Aircraft (The Hague, 16 December 1970)

**Action: San Marino: Accession** 

This instrument was received and deposited in the archives of the Government of the United Kingdom of Great Britain and Northern Ireland on 2 February 2015. Protocol for the Suppression of Unlawful Acts of Violence at Airports serving International Civil Aviation, supplementary to the Convention for the Suppression of Unlawful Acts against the Safety of Civil Aviation, done at Montreal on 23 September 1971 (Montreal, 24 February 1988)

In accordance with Article VI(1), the Protocol entered into force for the Republic of San Marino 4 March 2015, 30 days following the date of deposit.
