Item 1: MOT test fee increase from Tuesday 6 April 2010

The MOT test fee maximum is changing (see Annex A). You may charge the revised fees **on or after Tuesday 6 April 2010**.

You will shortly be receiving in the post the new MOT Test Fees and Appeals poster (VT9A). You must ensure that you add your local VOSA Office address and display the poster on your MOT notice board.

In the event that your revised fees poster does not arrive in time you may temporarily use Annex A of this Special Notice and place over the left hand side of your existing fees poster.

Item 2: MOT test slot fee increase from Tuesday 6 April 2010

The current test slot fee of £200.00 will increase to £205.00 for 100 slots with effect from Tuesday 6 April 2010.

AEs requiring additional test slots are advised to order them in good time due to increased demand leading up to the fee increase. To avoid delays you should, wherever possible, use your VTS device to place your order.

AEs are reminded that the **maximum number of test slots** which may be retained by a site is;

- no more than they would normally expect to use in a three month period (based on the Average Number of Test per Day from the Scheme Performance Report), or
- 200, which ever is the greater.
