Your email dated 26<sup>th</sup> March 2015 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

*Under the Freedom of Information Act 2000 I seek information about the Ministry of Defence's contracts with Grundon that are ongoing or ended on or after 01/01/2009.*

*I would be grateful if you could please confirm the total value, start date, duration and description of the relevant contracts*

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. The MOD does not hold any current contracts with Grundon. However, during the period indicated in your request, the MOD did hold seven contracts with Grundon Waste Management Ltd for the purposes of waste disposal. The details for each contract are given in the table below.

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
