1. How many complaints have been made by members of the public about the conduct of officers in your police force?

A total of **353** complaint cases were recorded between 01/01/2006 and 09/12/2015. A total of **849** complaint allegations were linked to these complaint cases – see breakdown per year below (Table 1).

The table below reflects the number of complaint allegations recorded in relation to cases recorded since 01/01/2006 only. Further complaint allegations may have been recorded during this period (e.g. a complaint case recorded in 2005 with an allegation added to the case in 2006).

It is noted that more than one officer may be linked to each allegation.

The **121** substantiated complaint allegations recorded between 01/01/2006 and 09/12/2015 originated from **54** separate complaint cases.

It should be noted that:

- A number of complaint allegations had more than one subject officer linked
- There were instances in which the same subject officer(s) was linked to multiple allegations within the same case, or in different cases. The tables below are therefore not reflective of the total number of subject officers linked to complaint cases.
- In some cases, officers received different consequences for different allegations within the same case (e.g. 1 x allegation resulted as NFA and 1 x allegation resulted as Advice). In such instances, the most serious sanction only has been included in the table.

One assault related allegation was substantiated (case recorded in 2013). This case involved one subject officer who resigned from the force prior to the completion of proceedings. The officer was found guilty of the charge of Common Assault. Received 18 months Conditional Discharge and fined £685 for costs plus £15 victim surcharge.
