

**Statistics Form For Local Authorities:  
Taxi and Private Hire Vehicle Licensing**

**1 April 2010 – 31 March 2011**

**ABOUT THIS FORM**

This return is for Local Authorities and requires information on taxis, private hire vehicles, taxi and private hire vehicle drivers and private hire vehicle operators. The form is divided into sections, as follows:

SECTION		INFORMATION REQUIRED
1.	Licensed Taxis	Number of licensed taxis at the end of the reporting period, the number with and without wheelchair accessibility, whether you have a requirement for wheelchair accessible vehicles, limits on number and age of taxis in area
2.	Private Hire Vehicles (PHVs)	Number of licensed private hire vehicles and age limits on vehicles
3.	Taxi and PHV Drivers	Number of taxi and PHV drivers, frequency of taxi and PHV driver licensing, knowledge tests and disability awareness training for drivers, and the number of medical exemptions from the obligation to carry assistance dogs.
4.	Private Hire Vehicle Operators	Number of PHV operator licences and frequency of licensing
5.	General	Space to notify DfT of any major changes that might have affected this year's form and to enter any comments pertinent to the figures submitted

## 1. Licensed Taxis at 31 March 2011

This section refers to licensed taxis ONLY, it excludes private hire vehicles
