Thank you for your email of 14th May 2015 requesting the following information:

"the number of ongoing ANA projects, correct as of 14 April 15, for both existing SFA and new SFA applications broken down by location.

"the date that the initial application/request was received by DIO/CA for each of the ANA projects detailed above."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that all the information in scope of your request is held.

The information is enclosed at Annex A. Please note that there are 51 ongoing ANA projects and that where a date was included on the SFA application or a record of being requested otherwise is held, the final column on the spreadsheet has been completed. It is reasonable to assume that for the majority of accommodation where no date is given that the 'Date Created' column is the date of request.

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
