## **AUTHORIZED AMENDMENT**

After feedback from the regulated community, internal review and the publication of the report into the Hawker Hunter crash at Shoreham by the AAIB, RA 2335 has been significantly amended. The aim of the change is:

To reduce the level of risk associated with Flying Displays, Role Demonstrations and Flypasts to ALARP.

The major changes are summarised below (with the first two being changes from the NPA version); of note the Regulatory Article has been amended significantly and must therefore be read fully.

- 1. Addition of Display Area to the Regulation.
- 2. Additional protection for 3<sup>rd</sup> party spectators outside a Flying Display venue.
- 3. Military registered aircraft can only conduct Flypasts and role Demonstrations at non-MOD Occupied Property unless Article 86 permission has been granted by the CAA.
- 4. All Flying Displays will be categorised into Tiers.
- 5. All FDDs must be appropriately experienced and accredited through a joint CAA/MAA training course.
- 6. The military category of Special Event has been removed.
- 7. Warning and Stop call procedures have been added.
