Description of change:

The amendment of codeset D00020, to include new categories for children from year "zero" ie to cover the years from birth through to current 'N1'.

Data item (100068) <NCyearActual> and codeset D00020 are used in the school census and CTF. If this RFC is approved a new data item will be introduced to replace (100068) with a new CBDS number referring to the new codeset, all other metadata will remain the unchanged.

Codeset D00020 is also referenced by two other data items (200560) <YearGroup> and (100486) <NCyearLeaving>, which are both collected in the school census. Any change to the codeset D00020 will therefore also affect these two data items and so this RFC also seeks to replace those two data item to ensure consistency of definitions in school systems.

Reason for change (including benefits):

Nursery education within schools is currently recorded via the codes 'N1' and 'N2' with 'N1' used for children aged 2 at 31 August but turning 3 during the year and 'N2' for children aged 3 at 31 August but turning 4 during the year.

Whilst the department does not differentiate between the existing 'N1' and 'N2' categories, schools are increasingly asking for earlier categories to be available under which they can record young children.

This proposed amendment to the existing codeset will see two new codes that will acknowledge the new requirement - without impacting existing arrangements - and schools will remain able to place children in whichever year group best suits the child's needs.

Whilst it is not expected that children below the age of 1 year old would, generally, be within the school system, a code 'E1' (Early first year) has been included to future proof the codeset against such a possibility.

Codes 'E1' (Early first year) is for children aged 0 at 31 August by turning 1 during the year and 'E2' (Early second year) for children aged 1 at 31 August but turning 2 during the year. These proposed year groups will provide maximum flexibility in recording 'pre-N1' children. It will be left to schools to determine how they wish to use these new codes to best suit their needs.

It is hoped that this change will provide a helpful and flexible framework for schools to accurately record the children within their care.

Impact of not doing the change:

Increasing numbers of young children are now receiving free early education and some local authorities have to manually adjust their records in order to place young children in a separate NC year group in their systems. This places a burden on these local authorities who have to process an increasing amount of suspense files from schools, and amend the NC year group to match pupils for their local analysis and reporting.

Findings as follows;

Phonics uses NCYearActual but only stores data for those in NC years '1' and '2', no other years apply. AP, EYC, EYFSP, KS1 do not use NC Year, though they are pupil-level collections. Other collections are not pupil-level as they are aggregated and/or LA-level.

XML Schemas for CTF, Admissions and ULN-provisioning all have NCYearactual and the type definition is held in the include file 'years.xsd'.
