AUTHORIZED AMENDMENT

Issue 6 to MAP-01 has sought to introduce the following changes:

1. 4800 series. NAA 14/05 dated 13 Feb 14 published the update to MRP Pt 145 4800 series regulations; this included changes to a number of other 4000 series regulations. These changes had impact upon regulatory cross reference into 100 MAP-01 chapters. These have been updated into Issue 6 of MAP-01.
2. Request For Change (RFC). Issue 6 has addressed 54 separate RFC/MOD F765 submitted against the MAP-01, either through acceptance, partial acceptance or rejection. The majority of these RFC were minor amendments but more significant chapter changes include:
 - a. Ch 0.7. Authority Levels and Tasks - Update to reflect regulatory requirements to be met by 2nd & 3rd signatures.

b.	Ch 2.8. Flight Servicing - Flight servicing validity period.
c.	Ch 4.1. Training and Competence Update of Assessment criteria and Supervisory Responsibilities.
d.	Ch 4.3. Engineering Authorization - Supervisory Responsibilities.
e.	Ch 7.2. Recording of Aircraft Maintenance - Corrective maintenance: 3rd signature responsibilities.
f.	Ch 10.5.1. Special Instructions (Technical) - Instructions affecting the Safety Case and/or Release to Service.
g.	Ch 10.5.4. Special Technical Instructions and Servicing Instructions – Layout SI(T) addressee acknowledgement.
h.	Ch 11.4. Wear Debris Monitoring - Wear Debris Monitoring sample results and maintenance action reporting.
i.	Ch 12.1.5. Aircraft Fibre Optic Systems - Chapter completely revised.
j.	Ch 12.6. Aircraft TEMPEST Testing - Chapter completely revised.
