Fraud and Error Reduction Incentive Scheme 2015/16 Funding

Introduction

1. This circular sets out the arrangements for distributing the Fraud and Error Reduction Incentive Scheme (FERIS) funding to local authorities (LAs) in 2015/16, specifically potential payments for meeting the FERIS threshold, and the application process for the maintenance fund.

Background

- 2. In November 2014, ministers announced that funding will be made available to LAs through FERIS, in order to significantly reduce Fraud and Error (F&E) in the Housing Benefit (HB) caseload during 2014/15, 2015/16 and beyond. FERIS is a 16 month scheme running from November 2014 to March 2016.

Maintenance fund

- 4. The maintenance fund, totalling £9.4 million in 2015/16, aims to provide LAs with funding to maintain start-up fund activities or to put in place new activities in order to meet the FERIS thresholds. Each LA will be allocated a set amount in proportion to their estimated 2015/16 HB administration subsidy, with a de minimis amount of £5,000 for the smallest LAs in recognition of the base costs of putting plans and resources in place.
- Maintenance fund Q&A and criteria is set out at Annex A and B. Each LA's
 potential maintenance fund payment is detailed at Annex C. Decisions on
 applications will be notified to LAs 20 working days following receipt of the
 applications (or from when all requisite information is received).
- 6. To provide the necessary financial controls and assurance, the Department for Work and Pensions (DWP) consulted with LA representatives and agreed that the maintenance fund payment will be made in two halves for applications in excess of £10,000. The first payment will be made at the time the application is approved. The second payment will be made by the end of October 2015, subject to the LA having met their lower threshold in one of the previous performance periods. Where performance has fallen short of the threshold the second payment may still be awarded if reasonable mitigating circumstances are demonstrated.
- The final performance data for the first performance period in 2015/16 (quarter 1) will be available in mid-September 2015. DWP will consider provisional performance data prior to September and engage with LAs whose

performance is not in line with meeting the lower threshold in order to support the LAs to improve, and to assess mitigation where the LA falls short of the threshold. By the end of October 2015 all LAs will be notified whether they will receive the second maintenance fund payment and receive payment as appropriate.

FERIS baseline

- 8. FERIS aims to encourage LAs to find as many changes of circumstances as possible which reduce HB entitlement, in order to reduce the monetary value of fraud and error (MVFE).
- 9. In order to set a threshold to achieve a FERIS payment, LAs have been assigned a baseline from which performance can be measured. Baseline performance is taken from the Single Housing Benefit Extract administrative data, and is based on the value of reductions to weekly HB entitlement. Each LA has been issued a personalised letter sent setting out their individual baselines in line with the following criteria:
 - Quarter 1 baselines on either performance in Q1 2014/15, or the average of performance in Q1 2014/15 and Q1 2013/14, whichever is higher.
 - Quarter 2 baselines on either performance in Q2 2014/15, or the average of performance in Q2 2014/15 and Q2 2013/14, whichever is higher.
 - Quarter 3 baselines on either performance in Q3 2013/14 or the average of performance in Q3 2013/14 and Q3 2012/13, whichever is higher.
 - Quarter 4 baselines on either performance in Q4 2013/14 or the average of performance in Q4 2013/14 and Q4 2012/13, whichever is higher.
- In order to use pre-FERIS performance to set all baseline periods for 2015/16, the quarter 3 and 4 baselines use performance periods further back i.e. 2013/14 and 2012/13.

Impact of Universal Credit on FERIS

11. DWP notes that Universal Credit may impact HB caseloads, but as Universal Credit is being rolled-out in tranches, it is not possible to evaluate the impacts at this time. Therefore, we commit to review baselines at the end of 2015/16 and make modifications if Universal Credit has had a significant impact on LA caseload composition, to ensure that LAs have not been disadvantaged by the impacts of Universal Credit. Adjustments would be factored into the final 2015/16 payments.

FERIS thresholds

12. Each LA will be set a lower and upper threshold for each performance period based on a percentage improvement above the baseline. In 2015/16 there will be a lower threshold of 10% and an upper threshold of 20%.

13. If the performance period ends and the LA has not met the upper threshold there are intermediary thresholds set at 2% points between the lower and upper threshold. The second (top-up) payment will be equivalent to an additional 0.25% of the HB administration subsidy for that year, for every two percentage point improvement in performance from the lower threshold up to the upper threshold.

Table 1: Percentage of HB administration subsidy LAs can receive at each point of the threshold per quarter.

FERIS payments

- 14. The total amount that an LA could receive from FERIS is equivalent to 10% of the HB administration subsidy for that financial year, calculated pro-rata for that performance period.
- 15. LAs can receive a maximum of two payments per performance period (quarter) or eight payments for the year. When an LA increases their performance to the lower threshold level this will trigger an immediate initial payment equivalent to a percentage of their HB administration subsidy. A second payment will be made at the end of a performance period and will be based on the final 2% point threshold exceeded, up to the upper threshold.
- 16. DWP will monitor progress and the payments will automatically be made to each LA that has opted in when meeting the FERIS thresholds as described above.
- 17. DWP will send monthly reports to LAs setting out their progress against the threshold. Lower threshold payments will be made within 15 working days of the monthly report that sets out that the LA has met the lower threshold. Second payments will be made within 20 days of the end of the quarter.

Worked example

18. A worked example of potential payments for the FERIS and maintenance fund is set out below. The incentive payments are between 1.25% (lower threshold) and 2.5% (upper threshold) of what the 2015/16 subsidy amount would have been before an assumed 10% cut.

Annex A: Maintenance Fund Application Q&A

1. What type of activities will receive maintenance funding?

The maintenance fund aims to enable LAs to continue activities put in place under the start-up fund or to fund new activities which will help them meet the lower FERIS thresholds. Key areas of activity are listed below, but each application will be assessed on its merits in line with this criteria:

- the cost of additional staff resource to do more pro-active work to identify F&E (including new staff and/or overtime for existing staff)
- the cost of recruitment
- customer education/awareness (e.g. targeted mail shots)
- new processes relating to F&E (e.g. data matching, credit checks, diary dates)

In addition, a list of activities awarded start-up funding is set out at Annex B.

2. Should maintenance funding applications focus on activities targeted at new claims, and in-claims?

FERIS is focused on LAs identifying more changes and reductions in the HB caseload, therefore the F&E reduction plan activities should focus on in-claims (rather than new claims or point of claim) as that is where the majority of changes occur.

3. Can LAs apply for maintenance funding for solutions similar to FERIS products on offer from their IT software supplier?

If an LA's software supplier is providing a FERIS solution but you wish to propose an alternative, the LA must set out why they believe the alternative solution provides better value for money.

4. Can LAs spend maintenance funding in 2016/17?

The maintenance fund closes on 30 May 2015 and LAs are expected to spend the fund in 2015/16. However, we will take a view where stated plans marginally slip into 2016/17. LAs should make every effort to comply with the spending assumptions they submit with their maintenance fund applications.

5. If my LA does not meet the lower threshold in the previous performance periods, is it still possible to receive the second half of the maintenance payment?

Yes. DWP will monitor performance and where an LA's performance is not in line to meet the lower threshold PDT consultants will make direct contact with the LA to provide support to facilitate improvement. PDT will also prepare a report to set out whether the LA has demonstrated reasonable mitigating circumstances for not meeting the lower threshold.

6. Is there a right of appeal for LAs who are notified they do not qualify for a second payment?

No. Where an LA has not met the lower threshold in one of the previous performance periods, and DWP determine that reasonable mitigating circumstances have not been

demonstrated, the LA will be notified that no second payment will be made, and this is not subject to appeal.

7. What funding will be available in 2016/17 and beyond?

FERIS is a 16 month scheme (November 2014 to March 2016). There is no commitment for further funding for FERIS beyond 15/16.

8. Can LAs apply for funding to help to deal with RTI referrals and outcomes?

No, funding requests to assist RTI activity will not be approved as this is covered by new burdens funding.

Annex B: Activities approved under the start-up fund

Below is a list of some activities that were approved for start-up funding, which provides an indication of what may be suitable for maintenance funding. This list is not exhaustive.

- Recruitment, secondment or retention of experienced HB assessors to support additional intervention activities
- Targeted campaigns / publicity drives to encourage claimants to report changes of circumstances promptly
 - o leaflets in customer new financial year benefit letters
 - o posters
 - o webpages
 - o twitter/facebook
 - o surgeries in other council departments
 - o local media awareness
- Improved customer statements/decision notices
- Introduction of e-forms for improved customer notification of changes
- Establish internal data matching e.g. electoral role, taxi licencing, leisure membership
- Improvements to internal IT infrastructure, e.g. dual screen, telephones, office equipment, review/improve scripts for automated telephony services
- Stationary, postal costs (i.e. for advertising)
- To identify cases of suspected irregularity that do not meet the Single Fraud Investigation Service criteria for investigation
- Focus on quality checks (to identify potential to increase reported changes)
- Encourage linked council services to consider benefit claims (encouraging claimant reporting changes of circumstances) e.g. housing, social services
- Joint working with external services to identify discrepancies e.g. Experian, registered social landlords, the National Health Service, housing associations, to identify discrepancies
- Risk Based Verification/aka Partial Intervention Model, especially around where the customer:
 - o Is in work but no income change in 52+ weeks
 - receives occupational/private pension and no change reported for 52+ weeks
 - o has a non-dependent deduction but no recent changes reported
 - o has 2 or more jobs or zero hours employment
 - o has £12,500 to £16,000+ capital
 - o passported cases
 - o reviewing new claims within 3 months of HB award
- Additional software from LA IT Suppliers, particularly around identifying and communicating with high risk claimant groups
- Electronic customer reminder activities including nudge technologies e.g. automated SMS or emails with links to online forms
- Targeted reviews
- Behavioural insight
- Sharing good practice

Annex C: Potential FERIS and maintenance fund payments

The potential quarterly FERIS payments set out below are cumulative, so each figure is the combined payment an LA could expect to receive for achieving the corresponding threshold. For example, the maximum FERIS payment Aberdeen could get in a quarter is £25,005. They would receive £12,502 for meeting the lower threshold and then £12,503 for meeting the upper threshold making a total of £25,005.
