- all theory and practical test records we hold; we hold theory test information from September 2004 and practical test information from April 2004
- the date in which the candidate passed their test; therefore, if a candidate passed their car theory or practical test in 2011/12 on the seventh attempt and the six previous attempts were taken prior to 2011/12, the candidate would only be included in the pass information in the 2011/12 financial year and would be shown in that year as passed on the seventh attempt
