- A clear and positive case for Scotland remaining in the UK is evidenced by a series of well-received Scotland analysis papers.
- Understanding for the UK Government's position grows amongst people in Scotland through an effective communications strategy
- The UK Government position is well understood by overseas governments, businesses and institutions.
