Dear Richard,

I would like to confirm that we have received your request to reimburse your travel and subsidence incurred whilst attending IPCC meetings in Yokohama, Japan. In order to process your claim, I need your assistance with a couple of matters.

Firstly, I note that the cost of your flight was £1,245.15 and that this was flying in the 'Club World' class. In the email attached, REDACTED indicated DECC's policy to only reimburse Economy flights and that we would expect that cost to be around £800. On your claim form you indicate that you paid the price of an economy class flight and upgraded using your personal air miles. Do you have a receipt or confirmation from BA that you could send me to verify this? I also note that the fare was amended and that this increased the price of the flight by £578.15. Was there a reason for this amendment?

Secondly, on your claim form you request to be reimbursed for £269.23 for subsidence whilst you were in Japan. This has been calculated using a rate of Y9,283.50/day. In the letter and guidance you were sent on 6 February 2014 the daily limits for subsistence expense claims were outlined. These are the maximum daily costs DECC is prepared to refund, when accompanied by receipts, and should not be treated as a daily base rate. Could you therefore send me any receipts you have for food/drink whilst in Japan so that I can reimburse the actual costs incurred.
