ANNEX B

<u>Impact Assessment – Section 9 Academies Act Duty</u>


1. Section 9 of the Academies Act 2010 places a duty upon the Secretary of State to take into account what the impact of establishing the additional school would likely to be on maintained schools, Academies and institutions within the further education sector in the area in which the additional school is (or is proposed to be) situated. Any adverse impact will need to be balanced against the benefits of establishing the new school.

Background

- 2. Langley Hall Primary Academy (LHPA) will be a 364 place (2 classes of 26 from reception to Year 6) co-educational primary school for children aged 4 to 11 located in Slough. The school is without any faith characteristics or a particular pedagogy such as Steiner or Montessori. Its curriculum places a high priority on the teaching of Literacy and Numeracy as well as a strong commitment to creative learning and personal, social and emotional development. The basics will usually be taught in the mornings and the afternoons will be devoted to Drama, Music, Art, Dance, Games, Swimming, Philosophy, Life Skills, Citizenship, Religious Education and Foreign Language teaching. Science, Geography and History will be taught, utilising a blend of subject and cross curricular methods. In the 5 mile radius around LHPA there are a total of 31 maintained primary schools, 2 independent primary schools, and 1 special school. As well as these primary schools, there are also 12 secondary schools within the 5 mile radius, 1 of which (The Langley Academy) is an Academy.
- 3. As part of their consultation, LHPA held an open evening at the site of the proposed school, which was attended by 377 local people, including: local residents, prospective parents, local businesses, local councillors and the Mayor. During the open evening, a total of 58 response forms were completed, all of which held positive views of the proposed Free School. The consultation submitted by LHPA also demonstrates the need for more primary education places within Slough, stating that:
- 4. "Since 2001 / 2007, births have increased by 31.7%. Numbers rose by 8.9% between 2006 and 2008 and by 10% the year after. 2007 figures show that 2,457 births were recorded. The difference between the projected demand [for school places] in September 2010 and availability is 155. The following year (2011) this shortfall of places is expected to rise to 342 places".
- 5. This impact assessment focuses primarily on the potential impact of the proposed school on local maintained primary schools. The assessment looks at where children who might attend the proposed school may otherwise have gone to school.

Catchment area

6. LHPA received a total of over 220 applications prior to opening this September, and gave places to 182 students, which means that the school is at full capacity for its first year, before eventually expanding to 364 pupil places. LHPA is suburban primary school without a specified catchment area, so we have chosen to look at the potential impact on schools within a five mile radius of the proposed LHPA site, because we consider that to be the widest limit of any potential impact of any significance that this school would have on other schools in the area.



Impact on schools in the local area

7. We have approached this analysis on the assumption that those schools closest to the proposed site are likely to be at risk of greater impact, as are those that are rated *Inadequate* and those that have existing significant surplus places nearby. Since distance is significant when assessing the impact for primary schools, the underperforming schools and those operating with surplus places have been listed in order of distance from the proposed school, starting with those closest to the proposed site.

8. We have also included an assessment for Parlaunt Park Primary School which was rated *Satisfactory*, since LHPA expect to take some pupils from this school. Conversations with the Local Authority (see paragraphs 40-42) have revealed that, due to the shortage of primary school places in the local area and the continued expected shortfall of places in the future, they do not think the opening of LHPA will have an adverse affect on any one particular local school. In view of this, we did not consider it necessary to look at other schools rated *Satisfactory* for the purpose of this impact assessment.

Closest school to Langley Hall Primary Academy

- 9. <u>Marish Primary School</u> is a maintained school that is situated approximately 0.30 miles from LHPA's proposed site. It caters for 3–11 year olds. It currently has 697 pupils on roll with a capacity of 705 pupils. It is therefore operating with a -1.13% surplus capacity.
- 10. The school was last inspected in 2009 and was placed in a category *Inadequate*. Performance data from 2007–2010 shows 75.3%/ 74.3%/ 63.3%/ 73.6% of pupils are achieving KS2 in English, Maths and Science, compared with the LA average of 78.3%/80%/79%/79%, and the national average of 82%/83%/83%/83%. 24% of its pupils are eligible for Free School Meals.
- 11. The impact of LHPA on Marish Primary School is likely to be moderate. LHPA expects to draw some pupils from the school, however, Marish Primary School is currently running near capacity, and has KS2 exam results that are close to the LA average. Marish Primary School also has a nursery on site, which is likely to be where it will gain many of its reception students who will then continue through the school until they progress to KS3. Schools in the area are going to be admitting children over the next few years that are a part of the increased birth rates within Slough, and as such, Marish Primary School is likely to lose significant pupil numbers and become unviable.

Local underperforming maintained schools (rated - Inadequate) and maintained schools operating with a significant pupil surplus (more than 5%)

- 12. <u>Parlaunt Park Primary School</u> is a maintained school that is situated approximately 0.40 miles from LHPA's proposed site. It caters for 3-11 year olds. It currently has 495 pupils on roll with a capacity of 490 pupils. It is therefore operating with a +5% surplus capacity.
- 13. The school was last inspected in 2009 and was placed in a category *Satisfactory*. Performance data for 2010 shows 87%/ 82%/ 84%/ 88% of pupils are achieving KS2 in English, Maths and Science, compared with the LA average of 78.3%/80%/79%/79%, and the national average of 82%/83%/83%. 12% of its pupils are eligible for Free School Meals.
- 14. The impact of LHPA on Parlaunt Park Primary School is unlikely to be significant. LHPA expects to draw some pupils from the school, however, Parlaunt Park Primary School is currently running above capacity, and has

KS2 exam results that are above the LA averages and above the national averages in all but one year.

- 15. <u>Foxborough Primary School</u> is a maintained school that is situated approximately 0.75 miles from LHPA's proposed site. It caters for 3-11 year olds. It currently has 432 pupils on roll with a capacity of 428 pupils. It is therefore operating with a +0.93% surplus capacity.
- 16. The school was recently inspected in 2010 and was placed in a category *Inadequate*. Performance data from 2007–2010 shows 68%/73.6% 57%/76% of pupils achieving are KS2 in English, Maths and Science, compared with the LA average of 78.3%/80%/79%/79%, and the national average of 82%/83%/83%/83%. 34% of its pupils are eligible for Free School Meals.
- 17. The proximity of Foxborough Primary School to LHPA's proposed site means that it could potentially lose some of its students to LHPA, although there is no evidence to suggest that numbers would be significant. Foxborough Primary School has a well-above average proportion of pupils that have SEN, some of which may be referred to LHPA. However, the proportion of pupils who either join or leave the school other than at the usual times is above the national average, and we would expect that any pupils that do leave the school would be replaced due to the increasing demand for local primary school places in the area. In view of this, while there may be some impact on Foxborough Primary School, in the long-term this is unlikely to be significant.
- 18. <u>IQRA Slough Islamic Primary School</u> is a voluntary aided maintained faith school that is situated approximately 1.65 miles from LHPA's proposed site. The school caters for 4–11 year olds, and is an Islamic faith school. It currently has 630 pupils on roll with a capacity of 630 pupils. IQRA Slough Islamic Primary School is therefore operating with 0% surplus capacity.
- 19. The school was recently inspected in 2010 and was placed in a category *Inadequate*. Performance data from 2007, 2009 and 2010 shows 72.6%/64.6%/62.6% of pupils are achieving KS2 in English, Maths and Science, compared with the LA average of 78.3%/79%/79%, and the national average of 82%/83%/83%. 25% of its pupils are eligible for Free School Meals.
- 20. It is highly unlikely that LHPA will have a significant affect on IQRA Slough Islamic Primary, due to the fact that although it was last rated *Inadequate* by OFSTED, the school remains at full capacity. It will be able to cater for Islamic teachings and standards in a way that LHPA will not be able to, which will appeal to a percentage of the Muslim population within Slough and the surrounding area.
- 21. <u>Iver Village Junior School</u> is a maintained school that is situated approximately 1.72 miles from Langley Hall Primary Academy's proposed site. It caters for 7–11 years olds. It currently has 163 pupils on roll with a capacity

for 186 pupils. It is therefore operating with a -12.4% surplus capacity

- 22. The school was last inspected by OFSTED in 2007 and was placed into the category *Good*. Performance data from 2007–2010 shows 74%/81.3%/85.3%/79% of pupils are achieving KS2 in English, Maths and Science, compared with the LA average of 78.3%/80%/79%/79%, and the national average of 82%/83%/83%/83%.13% of its pupils are eligible for Free School Meals.
- 23. It is unlikely that LHPA will have a significant affect on Iver Village Junior School, largely due to the fact that the school receives most of its pupils from its attached infant school, and the school also caters for a different age range to LHPA. It is unclear why there is a surplus capacity at Iver Village Junior School: the school has good OFSTED report and KS2 results that are above or on par with the LA average for the last three years, and close to the national average.
- 24. <u>Colnbrook Church of England Primary School</u> is a maintained school that is situated approximately 1.73 miles from LHPA's proposed site. It caters for 4–11 year olds. It currently has 202 pupils on roll with a capacity of 219 pupils. It is therefore operating with a -7.76% surplus capacity.
- 25. The school was inspected by OFSTED in 2010 and was placed into the category *Satisfactory*. Performance data from 2007, 2008 and 2010 shows that 53.3%/ 63.6%/ 61.3% of pupils are achieving KS2 in English, Maths and Science, compared with the LA average of 78.3%/80%/79%, and the national average of 82%/83%/83%. 22% of its pupils are eligible for Free School Meals.
- 26. It is unlikely that LHPA will have a significant affect on Colnbrook for it to become unviable. Colnbrook is a faith school and will be able to cater for Christian teachings in a way that LHPA will not be able to, which will appeal to a percentage of the Christian population within Slough and the surrounding area. The projected shortage of primary school places in the local area will also mean the school is unlikely to be significantly affected. The opening of LHPA could work as a catalyst and help raise the OFSTED ratings of some underperforming schools in the area, such as Colnbrook.
- 27. <u>Iver Village Infant School</u> is a maintained school that is situated approximately 1.88 miles from Langley Hall Primary Academies proposed site. It caters for 5 7 year olds. It currently has 139 pupils on roll with a capacity for 152 pupils. It is therefore operating with a -8.55% surplus capacity.
- 28. The school was inspected by OFSTED in 2009 and was placed into the category *Satisfactory*. Performance data from this school is not relevant, as it is an infant school, and so KS2 examinations are not taken by the student body. Only 3% of its pupils are eligible for Free School Meals.
- 29. LHPA is unlikely to have a significant impact on Iver Village Infant

School, due to the fact that LHPA caters for a different age range to Iver. The projected shortfall of primary school places in the local area also means that, in the long term, there is unlikely to be a significant effect on the viability of Iver Village Infant School.

- 30. <u>James Elliman School</u> is a maintained school that is situated approximately 2.38 miles from Langley Hall Primary Academy's proposed site. It caters for 3–11 year olds. It currently has 724 pupils on roll with a capacity of 725 pupils. It is therefore operating with a -0.13% surplus capacity.
- 31. The school was recently inspected in 2010 and was placed in a category *Inadequate*. Performance data from 2007–2010 shows 70%/67%/80%/65.3% of pupils are achieving KS2 in English, Maths and Science, compared with the LA average of 78.3%/80%/79%/79%, and the national average of 82%/83%/83%/83%. 23% of its pupils are eligible for Free School Meals.
- 32. The impact of LHPA on the James Elliman School is unlikely to be significant as the school is running at near maximum capacity. The proportion of pupils who have SEN at James Elliman School is much higher than the national average, and so the LA may feel that LHPA could cater for some of these pupils' needs, but the projected shortage of primary school places in Slough would mean it is unlikely that the school would become unviable in the long term.
- 33. <u>Western House Primary School</u> is a maintained school that is situated approximately 4.07 miles from Langley Hall Primary Academy's proposed site. It caters for 3–11 year olds. It currently has 507 pupils on roll with a capacity of 507 pupils. It is therefore operating with a 0% surplus capacity.
- 34. The school was recently inspected in January 2011 and was placed in a category *Inadequate*. Performance data from 2009 2010 shows 90.6%/ 93% of pupils are achieving KS2 in English, Maths and Science, compared with the LA average of 79%/79%, and the national average of 83%/83%. 14% of its pupils are eligible for Free School Meals.
- 35. The impact of LHPA on Western House Primary School is unlikely to be significant. Although the school received a poor OFSTED rating earlier this year, the KS2 results for the school since 2009 have been far above the local and national averages. The school is also a significant distance from the proposed LHPA site.
- 36. <u>Cippenham Junior School</u> is a maintained school that is situated approximately 4.39 miles from LHPA's proposed site. It caters for 7–11 year olds. It currently has 439 pupils on roll with a capacity of 445 pupils. It is therefore operating with a -1.34% surplus capacity.
- 37. The school was recently inspected in 2010 and was placed in a category *Inadequate*. Performance data from 2007–2010 shows 79.6%/85.3%/80.6%/85.6% of pupils achieving are KS2 in English, Maths and

Science, compared with the LA average of 78.3%/80%/79%/79%, and the national average of 82%/83%/83%/83%. 15% of its pupils are eligible for Free School Meals.

38. The impact of LHPA on Cippenham Junior School is unlikely to be significant. The school is currently operating at just under capacity, and the school has undergone expansion in the past year, and has more expansion plans for the year ahead due to anticipated demand for primary school places in the area. Clippenham also caters for a different age range to LHPA, and its results are higher than the LA average, and in some years, higher than the national average.

Nearby maintained secondary schools and post-16 institutions

39. LHPA will be admitting children of primary age. It will begin with 182 and will build up over the next few years to reach an eventual capacity of 364. As such, the school is unlikely to have any impact on local secondary schools, and even less likely to impact post-16 institutions. It is not a feeder school for any secondary education provider, nor do we believe it will impact significantly on any schools that are themselves feeder schools for any secondary education provider. The only way that LHPA will affect local secondary schools is with the additional number of 11 olds transferring to KS3 who will be attending schools in this area with the opening of this school. However, this would have to be addressed at some point, due to the increasing birth rates present within Slough, and the limited number of both primary and secondary school places.

Local Authority opinion

- 40. The project lead for LHPA wrote to the Director of Children's Services in Slough Borough Council, asking for thoughts and views of the proposed Free School.
- 41. The DCS chose to respond by telephone, and raised concerns about the disruption to children's education and the unbalancing of schools in relation to the fact that some pupils would be drawn from existing local schools. She did not think, however, that the opening of LHPA would cause any local school to become unviable because there is an acute shortage of primary school places in the local area.
- 42. The DCS stated that the uncertainty about whether the Free School would definitely open so close to the first day of term posed a problem in relation to planning for school places. She also spoke about a number of residents' concerns about the environmental impact of the school, such as how road usage would be affected, which are not relevant in the context of this assessment.

Conclusion

43. Taking into account the projected shortage of primary places in Slough

that are expected within the coming years, and the relatively small size of Langley Hall Primary Academy, the impact of the proposed Free School on existing schools is not likely to be significant. For only one school, Marish Primary School, would the impact be moderate, but even there it would not be sufficient to threaten the viability of the school, and as the number of primary school age children increases the impact will reduce. In terms of the LAs overall place planning picture, the new school would have a positive impact in terms of providing much-needed places. It could be argued that some pupils may transfer from schools with poor KS2 examination results, or schools with poor OFSTED reports

44. In the event that this does occur, then the schools that lose pupils will not be in any significant danger with regard to their long-term viability. The loss of pupils may also increase some underperforming schools' drive to achieve better results in the future, therefore pulling up the LA average results and increasing the area's educational prowess.
