Thanks for the call. I would suggest an approach along the following lines:

Under a number of International Conventions (e.g. SOLAS, MARPOL, STCW, Tonnage, Loadline, Bunker Liability, Maritime Claims, Harmful Ant-fouling Sysyem etc.) a number of statutory certificates are required to be issued to merchant ships by their Flag State or a Recognised Organisation acting on behalf of their Flag State. This is to demonstrate compliance by the operator, and is issued dependent mainly on the ship's type and Gross Tonnage.

The UK Administration has been approached by a number of organisations claiming to represent the Togolise Republic's interests in respect of the Togo-Flagged ship HORTEN (IMO 8746806), but we have been unable to verify through normal channels (GISIS) the authorisation formally given to each of these organisations. We would be most grateful if the Togolise Republic's Administration could confirm please, the organisations that have been recognised by it, that can issue statutory certification for their flag ships on international voyages and the extent of that authorisation.

All,

Having been away for a few days I am just now catching up with this (voluminous!) correspondence. My contribution to the debate is as follows:

 [Redacted] is correct, we don't generally recognise the concept of "demilitarisation" – if an item was originally "specially designed" for military use it will always be considered as military. In particular, entry ML9a1 of the UK Military List (the control that applies specifically to [Redacted]) states as follows (I have highlighted the most relevant text):

"Vessels" (surface or underwater) specially designed or modified for military use, regardless of current state of repair or operating condition, and whether or not they contain weapon delivery systems or armour, and components therefor specially designed or modified for military use

I should note that this text is the text adopted by the Wassenaar Arrangement, of which Norway is a Participating State, so if there is any difference of application of the controls we have a hook on which to hang any questions.

2. At this stage we should restrict our public comments to:

 We are aware of the stories in the Norwegian media regarding [Redacted]. We are cooperating with the Norwegian authorities to determine the actual facts of the case.

- [Redacted] is currently in the UK and is the subject of an export licence application. That application will be assessed in the usual way against the Consolidated EU and National Export Licensing Criteria taking into Account all the relevant facts and circumstances of the case.

I'm not trying to be awkward here I'm just worried that we may be getting ourselves in to a bit of a hole in trying to be as transparent as possible.
