Thank you for your correspondence dated 2 November 2015 requesting the following information:

'What appointments have been made at 3 *, 2* and 1* (vice admiral, rear admiral and commodore) level in the Royal Navy and Royal Marines for the period 1st January to 1st November 2015.

Could you tell me the officers names and the dates on which they assumed their appointment.'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

I can confirm that the Department holds the information you have requested and it is attached to this letter as Annex A.

Under exemption s16 (Duty to Provide Advice and Assistance) you should be aware that this information is passed on a regular basis to the quality press (The Guardian, The Times, The Daily Telegraph, The Independent) to consider for publishing. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail <u>CIO-FOI-IR@mod.uk</u>). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.



If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
