Exchange of Letters between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the French Republic relating to the Delimitation of the Exclusive Economic Zone (Paris, 20 April 2011) has been published as Treaty Series No.19 (2014) Cm 8931. The agreement entered into force on 31 March 2014.

Exchange of Notes between the Government of the United Kingdom of Great Britain and Northern Ireland and the Kingdom of the Netherlands amending the Agreement of 6 October 1965, as amended by the Protocol of 25 November 1971 and the Exchange of Notes of January and June 2004 concerning the boundary between the respective Exclusive Economic Zones of the United Kingdom and the Netherlands (The Hague, 19 April 2013) has been published as Treaty Series No.20 (2014) Cm 8932. The agreement entered into force on 1 April 2014.

Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Ireland establishing a Single Maritime Boundary between the Exclusive Economic Zones of the Two Countries and parts of their Continental Shelves (Dublin, 28 March 2013) has been published as Treaty Series No.21 (2014) Cm 8933. The agreement entered into force on 31 March 2014.

Protocol to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland, on the one hand, and the Government of the Kingdom of Denmark together with the Home Government of the Faroe Islands, on the other hand, relating to the Maritime Delimitation in the Area between the Faroe Islands and the United Kingdom, done at Torshavn on 18 May 1999, ("The Agreement") (London, 25 April 2012) has been published as Treaty Series No.22 (2014) Cm 8934. The agreement entered into force on 31 March 2014.
