## Dear XXXXXXX,

Thank you for your correspondence dated 26 January 2010 which has been considered to be a request for information in accordance with the Freedom of Information Act 2000. Your request has been passed to my department and I have been asked to respond.

You requested the following information:

I would like to request information on the number of members of the Armed Forces who have gone absent without leave (AWOL) for each year from 2000 to 2009, inclusive. I would also like each annual figure broken down into:

- (a) The number of permanent absconders
- (b) The number who returned voluntarily
- (c) The number who were located by police or army officials

The information you requested concerning Service personnel who have been categorised as Absent Without Leave (AWOL) between 2000 and 2009 is set out below. Where we cannot provide information the reason for non-disclosure is explained.

## **Royal Navy**

- Figures are not available pre-2001.
- The level of detail requested is not available for 2001-2006 inclusive as it is not held centrally as it is now in the Archives. The man hours required recalling this information

- and sifting through it to find the necessary breakdown would exceed the cost limit set by the FOI Act 2000. This is currently £600 for three and a half days work by one individual.
- The figures for 2007 and 2008 do not tally with the totals for those years as personnel, who were initially reported as missing, were found to be either sick or have a legitimate reason for being absent when they were found a day or so later. With the introduction of the Armed Forces Act 2006 an improved system of recording has been introduced.

The Army are unable to provide data on the number of permanent absconders, numbers who returned voluntarily or who were located by police or army officials as their data are not held in a format that allows for such a breakdown.

Please note that the total figures are for all incidences of AWOL, so the same individual may have been recorded as AWOL more than once.
