TREATIES FOR WHICH THE UK IS DEPOSITARY

BILATERAL TREATIES PUBLISHED THIS MONTH

Exchange of Notes between the United Kingdom of Great Britain and Northern Ireland and the Kingdom the Netherlands relating to the Convention Legal Proceedings in Civil and Commercial Matters, done at London on 31 May 1932 (London, 5-9 January 2012) has been published as Treaty Series No.15 (2014) Cm 8923. The agreement entered into force on 1 August 2014.

Exchange of Notes between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of the Philippines to amend the Treaty on Mutual Legal Assistance in Criminal Matters between the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of the Philippines, done at London on 18 September 2009 (Manila, 8 January 2014) has been published as Treaty Series No.16 (2014) Cm 8924. The agreement entered into force on 28 August 2014.

Protocol of 2002 to the Athens Convention relating to the Carriage of Passengers and their Luggage by Sea, 1974 (Adopted London, 1 November 2002) has been published as Treaty Series No.14 (2014) Cm 8922. The Protocol entered into force for the UK on 23 April 2014.

Regional Cooperation Agreement on Combating Piracy and Armed Robbery against Ships in Asia (Adopted Tokyo, 11 November 2004) has been published as Treaty Series No.17 (2014) Cm 8925. The Agreement entered into force for the UK on 2 May 2012.

International Convention for the Suppression of Acts of Nuclear Terrorism (Adopted New York, 13 April 2005) has been published as Treaty Series No.18 (2014) Cm 8926. The Convention entered into force for the UK on 24 October 2009.
