## Impact Assessment for Tyndale Community School

- 1. Section 9 of the Academies Act 2010 (later as amended by the Education Act 2011) places a duty upon the Secretary of State to take into account what the impact of establishing the institution would likely be on maintained schools, Academies, institutions within the further education sector and alternative provision in the area in which the institution is (or is proposed to be) situated. Any adverse impact will need to be balanced against the benefits of establishing the new school.
- We have carried out an Impact Assessment (see Annex B) which concludes that the impact on the majority of local schools should be minimal to moderate.
- Oxfordshire County Council is supportive of the Free School and views it as compatible with meeting the growing demands for school places in Oxford City.
- 4. Overall, we judge that the size and location of Tyndale Community School, coupled with the school's integration into the local authority strategic plan for the population growth in the city, means that any impact of the Free School is manageable. We expect there to be a moderate impact on seven schools, but no threat to the future viability of any school. The establishment of Tyndale Community School is likely to have a positive impact in improving parental choice by widening the number and type of places available, and by driving up standards in surrounding schools.
- 5. The assessment has concluded that the Free School will have a moderate to minimal overall impact on the majority of the surrounding primary schools in the OX4 and OX3 area. However the primary school population in Oxford is forecast to rise by 2.7% over the next four years, which is likely to mitigate some of the impact that the school will have on other schools.
- 6. In the light of the evidence, there is no reason why the Secretary of State should not enter into a Funding Agreement as a result of negative impact.
