

Staffing Toolkit National Rollout Programme

Commissioned by the Department of Health, NHS Commercial Alliance working with a number of NHS providers developed a staffing toolkit which provides practical advice, guidance and templates to help trusts seeking support to improve their internal controls and better balance safe staffing/patient care with the desire to reduce agency spend.

The toolkit covers a broad range of topics, including:-

- Diagnostic tool
- Sample policy and procedures
- Key Performance indicators
- Identifying and managing risks associated with agency staff use
- Assessing whether insourcing or outsourcing staff bank would be most financially beneficial
- Appointing and managing temporary agency suppliers
- Case studies of good practice.

The programme is supported by DH, Monitor and NHS TDA and includes several strands:-

- Two half-day Board level events to provide a high level overview of the programme; key actions and expectations from Monitor and TDA; and a practical session to introduce the diagnostic tool. Attendees should be a member of the trust board.
- Delivery of 6 Staffing Toolkit training workshops, held across England, these will be practical interactive full day events designed to provide a maximum of 2 trust representatives with the training required to best make use of the Staffing Toolkit.
- Delivery of 4 pilots—resources will be provided to assist the trust to test, develop and embed the toolkit. Trusts will be nominated by Monitor and TDA.

Given the objective of the workshops is to provide training on the elements of the toolkit. One or two delegates should attend the second workshop to learn about the staffing toolkit, ideally staff tasked to manage and reduce agency staff use. At least one delegate should have decision making authority to implement change as we will be looking for feedback on progress made with toolkit implementation.
