I am emailing with regards to a Ministerial Roundtable that the UK will be hosting on 10 February 2015 at the Mining Indaba in Cape Town (time TBC). This session will be in the margins of the Indaba and will be a private meeting between Ministers, mining companies and NGOs, to discuss how mining companies use the VPs to manage security and human rights risks around their operations. There will also be a discussion on the wider benefits of the VPs to explore their role in building a stable investment environment.
