Introduction to Internal Prisoner Movement Specification

Definitions used in Specification (Introduction and Outputs) below:

Daily Regime: Locally determined and published regime of daily activity and non-activity periods (commonly referred to as 'core day').

Main Movement: The commencement and cessation of activities in line with the typical Daily Regime. This will be to facilitate (not impede) the prison regime and *typically* takes place four times per day Monday to Thursday and twice per day on Friday (total of 18 Main Movements per week).

Individual Movement: Movement of a *single (or small number of) prisoner(s)* during Daily Regime periods to facilitate the delivery of services which were not previously arranged or where the prisoner's absence would be detrimental (for example, prisoner reporting sick whilst at work, or being late for an important Main or Group Movement such as visit or Offending Behaviour Programme). **While the need for these moves is predictable, the identity of the Prisoner concerned is not.**

Group (or Service) Movement: Movement of *Individuals or Groups of Prisoners* during activity periods (between Main Movement times, when the prison regime is active but the move cannot take place with Main Movement, either due to location or time of move; or outside of typical Daily Regime timings, such as religious or social 'events' (Visits or Gym) at times when there is no Main Movement facility e.g., evenings and weekends). *These moves are wholly predictable and in line with the prison regime, but are out of scope for this specification: appearing instead within the specification relating directly to the service concerned.*

Entry & Exit Points: An entry or exit point is the point at which the actual service commences or ends. For example, an establishment may have numerous wings that check prisoners off onto a central point where they leave the residential area to attend activities. *This would be a single entry point into this service*. Likewise, prisoner may enter a workshop complex and be checked in at the doors of each by an instructor. *This would be a single exit point out of this service*.

All types of movement may be:

Supervised: Staff supervise all movements directly, in order to ensure the safe and secure movement of the prisoner(s) between areas. Supervision may be supported by CCTV.

Unsupervised: While prisoners may not be physically supervised while moving between destinations, this may be within a secure area, and they are likely to be accounted for upon dispatch and arrival (outside of the scope of this specification).

Service Elements In Scope	Prisoner movement at Main Movement and unscheduled moves in-between these Main Movement times (where the movement is not directly attributable to another service: for example; a prisoner reporting sick or being late to attend an activity) ensuring that National Security Framework expectations are met and threats/risks to the establishment's security are raised and mitigated.

Strategic Context	This specification relates to main prisoner movement (which currently takes place four times per day Monday to Thursday and twice per day on Friday) and to individual 'unplanned' moves in between main movement times only. It is expected that the majority of prisoner movements between activity areas takes place at main movement time.
		Where moves cannot take place in line with this provision (either because of the necessary route, such as visits, which may be in a different area to main activities; or because it takes place at a time outside of the scheduled main movement, for example, a chaplaincy group or Physical Education 'changeover'), then it is expected that the cost of the service being delivered outside of main movement should be borne by the service concerned, and not by the Internal Prisoner Movement specification.
		The 'individual unplanned' movement element of the specification relates to the expected movement of prisoners between areas in such cases as 'reporting sick' where the actual move could not be planned, but there is a realistic expectation that such moves will need to take place during the usual working day within a prison. This service specification is largely a 'facilitator' service in that it <i>allows other services to be delivered</i> by ensuring that prisoners are in place, on time, to receive that service.
		The specification <i>does not</i> provide for the searching of or accounting for prisoners other than it provides safe and secure moves within National Security Framework requirements.
		Although the specification does not encompass accounting for individual prisoners, it is implicit that where a prisoner (or a group of prisoners) is moved, the service does ensure that the movement takes place. (A Residential Unit will account for prisoners leaving, a workshop for them arriving, and this service accounts for the physical move in between.)

		In the case of individual or smaller groups of prisoners being escorted under this service, it is implicit that the actual prisoner being escorted arrives at the destination, not just a prisoner. In effect, the prison's role in accounting for prisoners falls within separate specifications. Where adjustments to the process are required to ensure equality of access to all services by all prisoners within the establishment, this service is expected to ensure that wherever possible, movement takes place where the receiving service has approved attendance. In accordance with relevant guidance, it is appropriate to consider prisoner movement to and from activities as time in the open air (any periods spent outside moving between buildings, for example, moving to activities), but internal movements, for example: along corridors, should not be included.
8.	Flexibility	All the outputs in this specification are mandatory – referred to as the National Minimum .
9.	Reference to Supporting Documents	None.
10.	Example Measurement/ Assurance Method for Commissioners	The specification identifies examples of methods for Commissioners to measure/obtain assurance on the delivery of the outputs/output features. Where an output/output feature does not have Performance Indicator(s) or Management Information associated with it, then it is proposed that it should be covered by Assurance Statements and Contract/SLA Management and/or more specific audits of the service.
		Assurance Statements will be one of the means by which Commissioners can get assurance that providers are delivering outcomes and outputs of the Service Specification. Contract/ Service Level Agreement Management refers to the Commissioner, under the terms of the Contract/ Service Level Agreement, exercising appropriate oversight and monitoring of Contract/ Service Level Agreement compliance against the service as a whole. 'Audit' may refer to individual reviews of compliance commissioned by Commissioners or to service wide reviews, by MOJ Internal Audit and Assurance, of a key process contributing to the delivery of an outcome in a Service Specification.
