LOCAL AUTHORITY CIRCULAR ON THE PERSONAL CARE AT HOME ACT 2010 AND CHARGING FOR RE-ABLEMENT

Personal Care At Home Act 2010

- 1. The Coalition Government has decided not to commence the provisions in the Personal Care At Home Act. Therefore, the LASSL (2010)1 issued for consultation on 12 March this year and containing indicative allocations to Councils, is withdrawn.
- 2. On 21 June, a revision to the Operating Framework for the NHS in England 2010/11, was issued. In future, hospitals will be responsible for arranging and paying for aftercare, including any re-ablement, for the first 30 days following discharge from hospital. 2011/12 will be a transitional year as we move towards that goal, and local arrangements will need to be in place so that the NHS supports re-ablement further guidance on this will be issued later this year. In the meantime, Councils may wish to initiate early discussions with local acute hospital trusts and NHS commissioners on capacity issues.

Reablement

3. As part of the work on the Act, it became clear that in providing re-ablement services, the majority of Councils do not collect charges for the first six weeks and only raise charges where this extends beyond six weeks in accordance with section 15 of the Community Care (Delayed Discharges etc.) Act 2003 and the Community Care (Delayed Discharges etc.) Act (Qualifying Services) (England) Regulations 2003 (2003/1196) ("the 2003 Regulations"). The 2003 Regulations include the following definition of intermediate care -

""intermediate care" means a qualifying service which consists of a structured programme of care provided for a limited period of time to assist a person to maintain or regain the ability to live in his home." ²

Regulation 4(2) of the 2003 Regulations requires that intermediate care is provided free of charge for the first six weeks. Accordingly, re-ablement services are likely to fall within the definition of intermediate care services and should not be charged for for the first six weeks. Whether or not the re-ablement services provided to a person do in fact fall within the definition of intermediate services will need to be examined on a case by case basis. It is to be noted that "community equipment (aids and minor adaptations) service" (within the meaning of the 2003 Regulations), sometimes part of a package of re-ablement, is also to be provided free of charge where the cost of making the adaptation is £1000 or less whether as part of a reablement package or stand alone.

4. However, it appears that some Councils may have erroneously charged for the provision of re-ablement services on the basis that they are not intermediate care services. Councils should review the arrangements they have in place and satisfy themselves that these comply with the legislation with a view to repaying any amounts that may have been wrongly charged (and received).

2010/2011 Funding for re-ablement linked to hospital discharge

- 5. The Health Secretary announced on October 5th that £70 million of extra funding will be allocated to Primary Care Trusts (PCTs) to be spent this financial year across the health and social care system to enable the NHS to support people back into their homes after a spell in hospital through reablement. PCTs will work closely with Trusts and local authorities in delivering this. It will enable local areas to help thousands of people and ensure services are in place by the time the NHS picks up new responsibilities in April 2011 for patients' first 30 days at home after hospital discharge.
- 6. A letter from the Deputy NHS Chief Executive, David Flory, to SHA Chief Executives is being issued today that details the £70m allocations to PCTs is attached as a separate annex to this letter.

Cancellation of this circular

Circular LAC(2010)1 is cancelled with effect from 1st October 2011. This Circular also cancels LASSL(2010)1
with immediate effect.

Annex A – Letter from David Flory to Strategic Health Authorities Chief Executives regarding 2010/11 funding for re-ablement linked to hospital discharge

Allocations to PCTs of the additional £70 million available this year announced recently for post-discharge support are attached in the Annex to this letter.

PCTs will be allocated the additional funding via increased revenue resource and cash limit allocations. The PCT allocations will be actioned in time to appear in the next scheduled NHS allocation update, the NHS Limits report due to be issued on 4th November 2010.

PCTs should develop local plans in conjunction with the Local Authority and FT/NHS Trusts and community health services on the best way of using this money to facilitate seamless care for patients on discharge from hospital and to prevent avoidable hospital readmissions.

A proportion of this funding should be used to develop current re-ablement capacity in councils, community health services, the independent and voluntary sectors according to local needs. Resources can be transferred to local partners, including whether a pooled budget should be set up, wherever this make sense locally.

PCTs should use the plans developed for this year as a basis for co-ordinated activity on post-discharge support in 2011/12 and 2012/13 when changes to the tariffs will take effect. In 2011/12, non payment to Trusts for emergency readmissions will create savings for commissioners to reinvest in re-ablement and post-discharge support in year, whilst the intention is that from 2012/13 the tariffs are increased to cover the cost of post-discharge support, including reablement.

During 2011 we will be working with early implementer sites to consider issues for hospitals taking the responsibility (and associated funding) for post-discharge support. Our intention is to create as simple and transparent a system as possible, whilst recognising complexities such as patients who are treated by hospitals not in their local area.

Local partners should ensure that people leaving hospital have access to the appropriate levels of professional support that will enable them to live independently and, as far as possible, fully return to their way of life prior to hospital admission.

SHAs should ensure that each PCT has a local plan, developed with their Local Authority and local FT/NHS Trusts including monitoring arrangements, in place by the end of December 2010. For further queries, please contact: Reablementenquiries@dh.gsi.gov.uk or call 020 7972 4086
