As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

The footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this order ("the schedule") shall be stopped up and the Calne and Chippenham Rural District Council Definitive Map and Statement dated 1953 as modified by the Wildlife and Countryside Act 1981 shall be modified as provided below.
- 2. The stopping up of the footpath shall have effect on the confirmation of this order.
- 3. Where immediately before the date on which the footpath is stopped up there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.
