

#### Female Genital Mutilation (FGM) Community Engagement Initiative 2014

The Home Office is tendering £100,000 of EU funding which organisations can bid for in order to procure community engagement activities which will tackle and raise awareness of FGM within affected communities.

Bids can be submitted from voluntary sector organisations for amounts between £2,000 and £10,000. Organisations can apply individually or as a joint bid with another frontline organisation.

Please read the **guidance note** before completing the online application form to ensure you provide all the relevant information. Please ensure you answer all the questions.

As part of the bid you will need to provide your contact details. Please be assured that they will be treated as personal data by the Home Office in compliance with government guidance on holding personal information. All the information you supply will be held securely and will not be shared with other government departments or any other organisations. The information will be stored until the funding has been awarded to the successful applicants.

All applications must be received no later than 5pm on 6 March 2014. Any applications received after this time will not be considered.
