The migration and continued operation of the Unify2 collections through the Strategic Data Collections Service Direction 2017

I am writing to direct the Health and Social Care Information Centre, now known as NHS Digital, to establish the migration of the Unify2 collections included at Annex A onto NHS Digital's Strategic Data Collections Service (SDCS) and continue the operation of these collections through this service.

The Direction is given in exercise of the powers conferred by sections 254(1), (2)(a) and (6) of the Health and Social Care Act 2012 (the Act)¹ and Regulation 32 of the National Institute for Health and Care Excellence (Constitution and Functions) and the Health and Social Care Information Centre (Functions) Regulations 2013².

Pursuant to its powers under sections 254(1) and 254(6) of the Act, the Department of Health directs NHS Digital to establish and operate a system for the migration and continued operation of the specified Unify2 collections through the SDCS.

This Direction is to be known as **The migration and continued operation of the Unify2 collections through the Strategic Data Collections Service Direction 2017** and comes into force on 1 December 2017.

In accordance with section 254(2)(a) of the Act, the Secretary of State considers that the information which could be obtained by complying with the Direction is information which it is necessary or expedient for the Secretary of State to have in relation to the exercise by the Secretary of State of the Secretary of State's functions in connection with the provision of health services or of adult social care in England.

Annex A confirms the list of existing Unify2 collections to be migrated and the lead organisation. Updated technical output specifications will set out the data to be collected for each collection when ready. In the interim, reference will be made to the existing technical output specifications for each of these Unify2 collections to enable the migration over to the SDCS and continued operation. Once updated, the technical output specifications may be

reviewed and amended by the lead organisation from time to time for any of the collections included at Annex A. This will include consultation with NHS Digital.

In accordance with section 260(2)(d) of the Act and in order to maintain continuity with existing arrangements, the Department directs that NHS Digital is not to publish any data it collects as a result of the migration of the Unify2 collections specified at Annex A, unless and until notified to by the lead organisation.

NHS Digital must keep proper accounts, and proper records in relation to the accounts, in connection with the migration of the Unify2 collections onto its SDCS and their continued operation.

In accordance with section 254(5) of the Act, the Department has consulted NHS Digital before giving this Direction.

Please accept this letter as a Direction given under section 254(1) and 254(6) of the Act to NHS Digital to exercise the functions in relation to establishing and operating the migration of the Unify2 collections included at Annex A onto NHS Digital's Strategic Data Collections Service and their continued operation through this service.
