Report on: Provider Appraisal Update

Introduction:

- The Provider Appraisal directorate currently has eight active assessments, of which three started this month and another three are due for decision this month. There are three ongoing transaction reviews and two ongoing quality governance (QG) reviews of trusts still in the NHS Trust Development Authority (NHS TDA) phase.
- The allocation of the team's capacity over the next few months is likely to require some prioritisation of projects, given the expected increase in the number of assessments and transaction projects over the coming months. The directorate's medium term resourcing remains under review to ensure capacity is appropriately managed.

A. Developments

Continuous improvement

3. The senior working group set up to discuss goals around running an efficient, effective Provider Appraisal directorate and to consider further Key Performance Indicators (KPIs) met for the first time on 29 September and again on 3 October 2014. Further work is ongoing in smaller working groups, focused on desired behaviours and measurable outcomes in four domains (Collective Leadership, Engaged and Motivated Team, Internal Efficiency and Minimising the Burden on Trusts).

B. Update on assessments

4. The current status of trusts with Monitor for assessment is provided in Annex 1. Changes from last month are highlighted in red.

Active assessments (exception reporting)

5. Decisions are expected to be made this month on Royal United Hospital Bath NHS Trust, Bridgewater Community Healthcare NHS Trust and Derbyshire Community Health Services NHS Trust. The latter two, if authorised, will be the first community NHS foundation trusts (NHSFTs).

Assessment Pipeline

- 6. An overview of the assessment pipeline is provided in Annex 2. This reflects the NHS TDA's latest available published data (September 2014). The NHS TDA is planning to update and publish its analysis of its pipeline, including which NHS trusts may be considered not sustainable in their current form, in November 2014.
- 7. Oxford University Hospitals NHS Trust has now been referred for assessment. The Provider Appraisal team has already commenced work on this trust through a NHS TDA Quality Governance review which is on going. The team is now scoping the assessment work to follow on from the Quality Governance review, with an expectation of an executive challenge session later in the year covering Quality Governance findings and an early look at finances and target performance. This is to ensure an efficient process and that key issues are flagged with the Trust at an early stage.

C. Update on transactions

Active projects

8. Frimley Park Hospital NHS Foundation Trust's acquisition of Heatherwood and Wexham Park NHS Foundation Trust was completed on 1 October 2014. The Provider Appraisal and Provider Regulation directorates have met to co-ordinate a smooth handover.

Making a difference for patients:

Monitor's mission is to make the health sector work better for patients. This report provides an update on the Provider Appraisal team. The key focus of this team is to assess if providers are well led and can therefore deliver sustainable high quality services to patients.

It is not considered that there are any decisions within this paper which would impact on protected groups Identified by the Act.
