Thank you for your email to the Ministry of Defence (MOD) dated 9 April in which you requested the following information:

Of the 160 Brigadiers in the Army, how many are Black and Minority Ethnic (BME)?  
This request is also applied to the equivalent rank in the Navy and Air Force.

I am treating your correspondence as a request for information under the Freedom of Information Act (FOI) 2000. Following a search of our records, I can confirm that the MOD does hold information relating to your questions.

### Notes -

1. UK Regular Forces comprises trained and untrained Full-time personnel and excludes Gurkhas, Full Time Reserve Service personnel and reservists.
2. OF-6 is equivalent to the ranks of Commodore, Brigadier and Air Commodore in the Navy, Army and RAF respectively.
3. Black Asian and Minority Ethnic figures are based on those with a known ethnic origin – i.e. those that have chosen to declare. Please note that personnel are under no obligation to declare BAME status.
4. Royal Navy/Royal Marines

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
