- 3. Qatar is also engaged publicly and more privately in a constructive critical dialogue with the Guardian newspaper and NGOs/trade unions. The issue is the rights and living conditions of almost 2 million migrant workers (mainly from India, Nepal, Sri Lanka and the Philippines) constructing the country's new infrastructure. Here there is the potential for Qatar to turn a negative into a positive as the government has accepted that, under the World Cup spotlight, they have an obligation and an opportunity to transform. New legislation is ready and once adopted and implemented it would do away with most of the outdated traditional employment practices and offer the chance of Qatar becoming a benchmark for the region within a few years.
- 4. The Qatari response to the intense international pressure this last year has evolved. Initially, the authorities were stung by The Guardian's attacks. But senior Qataris know the UK well and recognise that HMG does not control the media.

1. In recent years Qatar has been associated with [Redacted] (d) poor treatment of migrant workers, particularly around the 2022 World Cup.

7. Hosting a successful 2022 World Cup will be part of this. The Qataris were taken aback by the media storm around their successful bid and then the focus on Qatar's record on migrant labour, especially as they see themselves as no better or worse than any other GCC country. On the latter, they have taken some positive steps – introducing electronic payment system migrant labourers, building better equipped and spacious accommodation facilities, more inspections and inspectors, and improvements to the exit visa system. But for the ILO (and international NGOs) these reforms while welcome don't go far enough, quickly enough; and there remains a serious issue around implementation of standards by subcontractors in particular. This issue is complicated by cultural factors and commercial interests.

Importantly, the Qataris also feel that we are now more supportive of the 2022 World Cup than before. This remains the key priority for them both politically and economically. The Prime Minister has been clear that all the infrastructure projects related to the World Cup will continue despite the dip in the oil price and the Qataris have been taking steps to address some of the international criticism of them over labour rights (including introducing on 13 December amendments to the Labour Law which replace the 'sponsorship' system for migrant labour with a contract-based approach and a landmark agreement between the World Cup Supreme Committee and Building Workers International on joint inspections of accommodation and work sites).
