# Information request

We urgently require the most recent figures available for Peterborough on the following:

- 1). Welfare Reform general:
- (a) The number of families in Peterborough who are in receipt of over £25000 in benefits who will be affected by Welfare Reform
- 2). Social Fund budget
- (a) The amount of Social Fund budget that Peterborough has been allocated by month for the last 3 years
- (b) How much of that allocation has been spent; and the breakdown of that expenditure
- 3). Pensioners
- (a) The number of pensioners in Peterborough whose partners are not of pensionable age
- 4). DLA
- (a) The number of people in Peterborough currently claiming DLA (most recent data)
- (b) How much less Personal Independent Plan funding is to DLA
- (c) The number of disabled people in Peterborough who received Employment Support Allowance
- (d) The number of disabled people in Peterborough who failed an Employment Support Allowance claim
- (e) The likely percentage of people currently claiming DLA who will lose or have reduced benefit income
- 5). Lone Parents
- (a) The number of Lone Parents who are claiming tax credits in Peterborough
- (b) What the reduction of tax credits will be, and how much that will be for Peterborough
- 6). Families with disabled children
- (a) The number of families who have disabled children included in tax credit claim
- (b) What the reduction will be, and how much that will be for Peterborough

- 7). Forms with errors
- (a) The number of forms identified in the past 3 years with errors (in Peterborough)
- (b) The cost of this in payment of fines
- 8). Contributory Employment Support Allowance
- (a) The number of people who claimed Contributory Employment Support Allowance based on NI for more than a year over the past 3 years
- (b) The amount of claims that will cease after 12 months and the loss of income to claimants

# **DWP** response

Our responses to your questions are set out below.

## Question 1 (a)

The information you have requested is shown in the table below. The table shows the estimated number of households likely to have their benefit reduced by the household benefit cap in the year 2013-14, when the benefit cap is implemented; and a subdivision into numbers whose reduction is: a) between £0 and £50 per week; b) between £50 and £100 per week; and c) more than £100 per week.

#### Question 3 (a)

The information that you have requested on the number of pensioners in Peterborough whose partners are not of pension age is not readily available.

We estimate that the cost of complying with your request would exceed the appropriate limit of £600. The appropriate limit has been specified in regulations and for central Government it is set at £600.

This represents the estimated cost of one person spending 3½ working days in determining whether the Department holds the information, and locating, retrieving and extracting the data. Under section 12 of the Freedom of Information Act the Department is not obliged to comply with your request and we will not be processing your request further.

### Question 4 (a)

Section 21 of the Act allows us to direct you to information which is already reasonably accessible to you.

- Scroll down and select Benefit Caseloads National Statistics (WPLS) data in the Benefit Data section
- 2. Under Benefit/Scheme, select Disability Living Allowance cases in payment
- 3. In the Analysis section, select Caseload (Thousands),

- 4. Next, in the Row option, select Local Authority
- 5. In the **Column** option, select the information you may require i.e. **Gender of claimant**,
- 6. Next, in the Subset option, select NONE,
- 7. Finally, in the **Date** option, select the latest date available, in this case **February 2012**.

## Question 4 (b)

The information that you have requested is not available.

There is no set funding for benefits. Personal Independence Payment is being designed to create a fairer, more transparent and sustainable benefit and to enable support to be focussed on individuals who have the greatest needs - it is not simply a cost-cutting exercise. Expenditure on DLA has risen by almost 34% in just under the last 10 years and reform was required to bring the benefit back onto a sustainable footing.

As a result of these reforms and focussing resources on those who need them most, we will continue to provide essential support for disabled people. Overall spending on Personal Independence Payment (PIP) and DLA will be higher in real terms in 2015-16 (£13.2 billion) than spending on DLA was in 2010-11 (£12.5 billion).

## Question 4 (c)

The information that you have requested on the number of disabled people in Peterborough who received Employment Support Allowance (ESA) is not readily available.

We estimate that the cost of complying with your request would exceed the appropriate limit of £600. The appropriate limit has been specified in regulations and for central Government it is set at £600.

This represents the estimated cost of one person spending 3½ working days in determining whether the Department holds the information, and locating, retrieving and extracting the data. Under section 12 of the Freedom of Information Act the Department is not obliged to comply with your request and we will not be processing your request further.

# Question 4 (e)

The information that you have requested is not available.

It is very difficult to make generalisations about who will leave the benefit, as entitlement is based on individual circumstances and the impact of disabilities, not on what condition people have. Some people will receive more support, some broadly the same, others less and some will leave the benefit altogether.

Those who leave are most likely to be people with conditions that have a low impact on their day-to-day lives and who have a high level of participation in society without needing expensive aids and appliances or a lot of help from others. They will come from across the full range of disabilities.

The current assessment criteria is not the final version. We are currently considering all of the comments received through the assessment consultation, and evaluating what changes need to be made. We will publish our response to the consultation as well as the main draft regulations later this year. However, many people who currently receive DLA will continue to receive support under Personal Independence Payment.

- 2. Under Benefit/Scheme, select Employment and Support Allowance
- 3. In the Analysis section, select Caseload (Thousands)
- 4. Next, in the Row option, select Payment Type
- 5. In the Column option, select the Duration of claim
- 6. Finally, in the **Date** option, select the date you require, in this case **February 2012, February 2011** or **February 2010 (done in separate tables)**.

#### Question 8 (b)

It is estimated that for GB as a whole, around 700,000 people will have been affected by time limiting contributory ESA by 2015/16. Whilst the time limit will remove contributory ESA payments for these claimants, approximately 60% are expected to be partially or wholly compensated by a corresponding increase in income-related ESA. The average loss in net income for all those affected is £36.
