We have a bit of an issue regarding the closure of a footpath off Shooters Hill Rd which leads to Academy Place Shown green on the map below).

Basically the path is on MoD land, it is not adopted and MoD have closed it earlier this year following complaints about littering, school children congregating there etc. etc.

Apparently they did contact us about the closure and we didn't object to it at the time and it was subsequently closed. We have since received a few complaints about the closure and loss of amenity and one of the complainants is claiming that he has been using the path for more than 30 years and therefore a public right of way has been established.

Looking at the Highways Act there would appear to be a right of way established where continuous use has been possible for 20 years unless the land owner has specifically registered the land as not being dedicated, although used by the public. MoD have forwarded me a number of historical documents (attached) which they believe supports their position that the path is not dedicated as a public right of way.

Could you have a look at the attached files and let me know what you think.

Following our telephone conversation last week I have discussed the matter with ... and my comments are as follows:

As far as I am aware as a private landowner we legitimately closed the FP. The piece of land was used as a cut through by members of the general public for access to the College Campus at the bottom of Red Lion Lane and reversely for access to the school on Shooters Hill. College students were using the area as a recreation centre to meet and socialise. Rubbish was being dumped causing a nuisance and possible Environmental issue as food waste was also being left. The Metropolitan Police were informed of the issues concerning Academy Place and the ongoing problem was discussed at a meeting with them.

On behalf of MoD, DIO consulted with The Royal Borough of Greenwich and the following facts were established:

The FP is MoD Freehold private ownership.

The FP is not considered by the Council to be a Public Right of Way.

The FP is not registered on any list of Streets and not entered into the Road Register, the statutory list of roads within the Royal Borough of Greenwich.

The FP is not Highway maintained at public expense and the Council have no authority over this land.

The Royal Borough of Greenwich Highways Dept had no objection to the MoD closing the FP.

The FP is a Woolwich Garrison asset who are responsible for its maintenance.

There were no registered public rights covering this portion of land and we were not under any obligation to follow a formal process to enable this closure. However notice was posted for a period of just over five weeks prior to the closure to inform the public of our plans.

The Closure Notice was erected at the entrance to the FP adjoining number 9 Academy Place at the beginning of Jan 2013 providing just over five weeks prior notice of closure on 8th February 2013 and gave a contact number for further details. This informed and enabled any user of the FP to contact the MoD and raise concerns.

It was not until 8th July that we heard from Mr Barbour by way of an FOI request which was fully replied to on 25 July 2013.

We did not consider the closure to be an inconvenience to the public as a suitable alternative was available. I have measured the Ordnance Survey map to compare the distance of walking down the existing public FP adjoining the Highway of Red Lion Road or using the route across MoD land via Prince Imperial Road and Academy Place and the now closed FP adjoining number 9 Academy Place to Shooters Hill. The additional distance of using the existing public FP rather than cut across the MoD land is approximately 3 meters.

Your e-mail or asks has any formal notification ever been lodged with the Royal Borough to the effect that there was no intention for this path to be a public right of way or is there any special status being MoD land?

There is a copy of a letter on file to Greenwich Council dated 23 November 1990 enclosing a Statutory Declaration dated 23 Nov 90 in respect of map number 96A/74 which was deposited with your council with supporting statement dated 20 February 1978 for MoD land at Woolwich Military Complex and Married Quarters under Section 34(6) of the Highways Act 1959. A revised map number 96B/74 was enclosed. (I do not have a copy of the original map number 96A/74 referred to, but it would appear a further copy was sent to the Council on 16/8/2000).

A letter dated 24 May 2000 enclosed a Statutory Declaration dated 11th May 2000 in respect of map numbered 96A/74 and referred to the supporting statements dated 20 Feb 1978. A revised map 96C/74 was enclosed. Greenwich Council acknowledged receipt by way of letter dated 13 August 2000.

I believe the actions above would have prevented any person or persons gaining prescriptive rights of public access, and I would be grateful if you could confirm this? I attach copies for your reference.

I would be grateful to receive a copy of your response to Mr Barbour.



- 1. The person I tracked down has at last responded that it is not his handwriting on the letter from your council dated 13 August 2000, the hand writing saying **Sent 16/8/2000** i.e. implying a further copy of plan 96A/74 had been sent to your council. I was hoping he would have confirmed it was him and provided a new stat dec to your council.
- 2. The Academy Place FP is within the boundary of The Woolwich Military Lands Byelaws of 1959 however although MoD can remove people if they are committing an offence under the byelaws, nothing in these Byelaws shall interfere with the lawful exercise by any person of any public right of way.
- 3. Although your legal section have commented on the MoD letter to the council fron 3 dated 23 November 1990 saying it is not conclusive, I believe the intention is clear, as the letter says he has inspected the Statutory Declarations lodged with the council (that would have included the plan 96A/74 deposited with your council with supporting statements dated 1978) and can find no evidence of a public right of way from Shooters Hill to Academy Place, and therefore in order for public access along these routes to be restricted as MoD see fit. His attached plan shows coloured red the Academy Place FP, confirming at the time, and subsequently by way of later stat decs, that there was no intention to grant public right of way over Academy Place FP, nor any other land within that edged red.



this issue over closure and the status of the "footpath" of Shooters Hill leading to Academy Place on MOD land has arisen before.

It is a question of whether the footpath has acquired the status of a public right of way by statutory presumption of deemed dedication because (*other than of a way of such character that use of it could not give rise at common law to any presumption of dedication) it has been used and enjoyed by the public "as of right" and without interruption for a full period of 20 years unless there is no evidence that there was no intention to dedicate it as such by the landowner. (Section 31 Highways Act 1980).


The 20 year period is calculated retrospectively from the date when the public right to use the way is bough into question, i.e. its closure by the MOD)

(*it is not made clear in the Act what kinds of ways should be of such a character that use by the public could not give rise to any presumption of dedication at common law, but this could be relied on by the MOD for security purposes)

This deemed presumption may be overturned if there is evidence of action taken by the landowner that there was no intention to dedicate including the following actions which will be sufficient evidence to negative the intention to dedicate the way as a public highway.

- i) If he has erected and maintained a notice which is visible to the public using the way which is inconsistent with any intention to dedicate,
- ii) If this is torn down or defaced a notice is given to the Council that the way is not dedicated as s highway;

Also a landowner may deposit with the Council a notice, scaled map and a statement indicating what ways he admits to having dedicated as public highways and within 10 years of the first deposit, a statutory declaration that no additional way over the land indicated on the map has been dedicated as a public highway since the date of first deposit. In the absence of



 $\frac{1000 \, J_{00} \, J$ way as a public highway.

To meet the requirement that use of the footpath must have been "as of right" without interruption for a full period of 20 years, it must have been used without the permission of the landowner (a licence or permission even implied permission negatives use as of right), without force or secrecy. So it depends on the facts and evidence of the claimed use as a public right of way.

The MOD

The MOD state in the email of 12/11/2013 that the footpath is within its freehold private ownership, is not considered to be or registered as a public footpath by the Council on its statutory list of highways in the Royal Borough. (it probably would not be registered as only maintained, non-maintained and housing estate roads are included on the statutory map and the Council does not have an adopted Definitive map of footpaths). Therefore they have no obligation to close the footpath by formal process, although they erected a closure notice at the entrance to the footpath at the beginning of January this year giving 5 weeks prior notice of closure. (this may imply that the MOD gave permission for the public to use the footpath and was just being considerate to users of the footpath by erecting a notice and temporarily withdrawing that permission).

The MOD deposited with the Council:

- i) map no. 96A/74 and supporting statement dated 20/2/1978 in respect of MOD land at Woolwich Military site and married quarters;
- ii) statutory declaration on 23/11/1990 with a revised map no. 96B/74 in accordance with s.31(6) of the Highways Act 1990, to the effect that no additional way over the land delineated in the deposited map 96B/74 has been dedicated as a highway since 20/2/1978 he date of the previous declaration.
- (iii further statutory declaration dated 11/5/2000 deposited in respect of map 96A/74 and a further revised map 96C/74 (acknowledged by the Council 13/8/2000), in accordance with s.31(6) of the Highways Act 1990, to the effect that no additional way over the land delineated in the deposited map 96c/74 has been dedicated as a highway since 23/11/1990 he date of the previous declaration.

Review of these documents.

As the Council does not have the deposited map 96A/74, accompanying statement and statutory declaration, which may have indicated what ways were admitted as being dedicated as public rights of way, (Highways dept. only has the two later maps and statutory declarations that no additional ways had been dedicated since 1978. Therefore without this map it is not possible to determine conclusively whether the path has not been dedicated as such. The two subsequently deposited maps and statutory declarations do not assist at all as they only serve to indicate that no additional ways have been dedicated. s 23/11/94 to Majo HQ Woolwich Garrison confirming that he inspected the statutory declarations deposited with the Council under s.31(6) of the Highways Act 1980 (which ones?) and could find no evidence of the existence of a public right of way from Shooters Hill to Academy Place or from Prince Imperial Road to Academy Place. This is not conclusive either.

Conclusion

The evidence and information provided is not conclusive so as to negative any intention of the MOD's to dedicate informally or formally the footpath as a public highway.

Although the footpath appears to have been used for a long period by the public and is claimed by one of the complainants that it has been used for more than 30 years, there are as yet no facts or evidence that support that the footpath has been used and enjoyed by the public "as of right" (i.e. without the MOD's express or implied permission or licence, openly, without force) and without interruption or a full period of 20 years, for a presumed deemed dedication as a public right of way. I can only suggest that the MOD is requested to re-provide the missing map 96A/74 and statement regarding what, if any, ways were admitted to be dedicated by the MOD at the site. If the Mod as landowner is relying on this action then it is for it

We have a bit of an issue regarding the closure of a footpath off Shooters Hill Rd which leads to Academy Place Shown green on the map below).


Basically the path is on MoD land, it is not adopted and MoD have closed it earlier this year following complaints about littering, school children congregating there etc. etc.

Apparently they did contact us about the closure and we didn't object to it at the time and it was subsequently closed. We have since received a few complaints about the closure and loss of amenity and one of the complainants is claiming that he has been using the path for more than 30 years and therefore a public right of way has been established.

Looking at the Highways Act there would appear to be a right of way established where continuous use has been possible for 20 years unless the land owner has specifically registered the land as not being dedicated, although used by the public. MoD have forwarded me a number of historical documents (attached) which they believe supports their position that the path is not dedicated as a public right of way.

Could you have a look at the attached files and let me know what you think.



Following our telephone conversation last week I have discussed the matter with and my comments are as follows;

As far as I am aware as a private landowner we legitimately closed the FP. The piece of land was used as a cut through by members of the general public for access to the College Campus at the bottom of Red Lion Lane and reversely for access to the school on Shooters Hill. College students were using the area as a recreation centre to meet and socialise. Rubbish was being dumped causing a nuisance and possible Environmental issue as food waste was also being left. The Metropolitan Police were informed of the issues concerning Academy Place and the ongoing problem was discussed at a meeting with them.

^{On} behalf of MoD, DIO consulted with The Royal Borough of Greenwich and the following facts were established; The FP is MoD Freehold private ownership.

The TP is not considered by the Council to be a Public Right of Way.

The FP is not registered on any list of Streets and not entered into the Road Register, the statutory list of roads within the Road Register. within the Royal Borough of Greenwich.

The FP is not Highway maintained at public expense and the Council have no authority over this land.

The Royal Borough of Greenwich Highways Dept had no objection to the MoD closing the FP.

The FP is a Woolwich Garrison asset who are responsible for its maintenance.

There were no registered public rights covering this portion of land and we were not under any obligation to follow a formal process to enable this closure. However notice was posted for a period of just over five weeks prior to the closure to inform the public of our plans.

The Closure Notice was erected at the entrance to the FP adjoining number 9 Academy Place at the beginning of Jan 2013 providing just over five weeks prior notice of closure on 8th February 2013 and gave a contact number for further details. This informed and enabled any user of the FP to contact the MoD and raise concerns.

It was not until 8th July that we heard from July 2013.

We did not consider the closure to be an inconvenience to the public as a suitable alternative was available. I have measured the Ordnance Survey map to compare the distance of walking down the existing public FP adjoining the Highway of Red Lion Road or using the route across MoD land via Prince Imperial Road and Academy Place and the now closed FP adjoining number 9 Academy Place to Shooters Hill. The additional distance of using the existing public FP rather than cut across the MoD land is approximately 3 meters.

asks has any formal notification ever been lodged with the Royal Borough to the effect that there was no intention for this path to be a public right of way or is there any special status being MoD land?

There is a copy of a letter on file to Greenwich Council dated 23 November 1990 enclosing a Statutory Declaration dated 23 Nov 90 in respect of map number 96A/74 which was deposited with your council with supporting statement dated 20 February 1978 for MoD land at Woolwich Military Complex and Married Quarters under Section 34(6) of the Highways Act 1959. A revised map number 96B/74 was enclosed. (I do not have a copy of the original map number 96A/74 referred to, but it would appear a further copy was sent to the Council on 16/8/2000).

A letter dated 24 May 2000 enclosed a Statutory Declaration dated 11th May 2000 in respect of map numbered 96A/74 and referred to the supporting statements dated 20 Feb 1978. A revised map 96C/74 was enclosed. Greenwich Council acknowledged receipt by way of letter dated 13 August 2000.

I believe the actions above would have prevented any person or persons gaining prescriptive rights of public access, and I would be grateful if you could confirm this? I attach copies for your reference.

I would be grateful to receive a copy of your response to Mr Barbour.




