Title: Orphan Works Licensing Scheme

Information request:

- 1. On the 6th October 2015, OrphanworksLicensing@ipo.gov.uk contacted those who had applied to the Orphan Works Licensing Scheme, attaching a survey to fill out to give feedback to the scheme organisers. I would like to know:
- a) How many people were contacted in total?
- b) What the response rate was to the survey (i.e. how many completed forms were returned)?
- c) I would like to see a copy of the forms that were completed. (I understand that personal contact details may have to be redacted).
- 2. I would also like to know, for the period between 29th October 2014 and 29th October 2015 (the first year the scheme has been operational):
- a) How many total applications for Orphan Works Licensing were received by the IPO?
- b) How many total individuals or institutions applied for these licenses?
- c) What the total monetary value of the licenses granted were.
- d) How many of these licenses were commercial, and how many were non-commercial?
- e) For the commercial licenses, what the total revenue was, and a breakdown of the spread of the cost of licenses across the different applications.
- f) For the non-commercial licenses, what the total revenue was, and a breakdown of the spread of the cost of licenses across the different applications.
- g) How many license applications were rejected (and the proportion of these that are commercial or non-commercial)?
- h) If licenses were rejected, I would like a summary of reasons for rejecting them that were given to applicants.
