These tables give the estimated yield from stamp duty on residential property, broken down by Standard Statistical Region up to 1996-97 and Government Office Region thereafter. The counties making up these regions can be seen in the make up of the regions for table 15.4. The estimates up to 2003-04 were derived using information from the Survey of Property Transactions in England and Wales, described more fully in the 'Property and Stamp Duties' section. The estimates for 2004-50 to 2011-12 were derived from the Stamp Duty Land Tax database. The Survey of Property Transactions in cover Scotland nor Northern Ireland and estimates for these regions were tentative up to 2002-03. However data provided by the University of Paisley was used for Scotland for 2003-04 and the Stamp Duty Land Tax Database was used for the years from 2004-05 to 2011-12. The estimates for Scotland for these years are of higher quality than for previous years. Due to the chang in data source for Scotland for 2003-04 and later years are not directly comparable with estimates for earlier years
