The ARAc can include some planned expenditure not paid for during 2014/15. For this answer we have had to take data based on bill payments made during 2014/15 by contractor and against specific RACs, which may have been incorrectly assessed at the time the bill was paid and may subsequently have been changed during the formulation of the ARAc.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
